The Board met with the members and public for a meeting on the Verde River Basin Partnership. The Board of Supervisors took no action at this meeting.

Mayor Von Gausig reviewed a letter of support to be sent to Senator McCain and requested feedback from those present. There were several comments for changes to the letter which were approved by the committees. Supervisor Springer said she was confused on how they could send a letter from an organization that had not been officially formed. Mayor Von Gausing that they had formed and were sending it under their formed name. Mayor Von Gausig then reviewed a draft letter to the tri-cities mayors. Supervisor Springer said the message being sent was not the message being received and the perception was that the structure of the partnership had not been formed but agendas, rules, committees had already been put in place. Mayor Von Gausig said the bylaws had not been made and that the tri-city entities had been invited and had declined. Supervisor Springer said mistakes had been made on both sides and that should not be dwelt on but actions were being taken and voted on when the partnership was not yet formed and did not exist. Mayor von Gausig said that only the three main entities had not joined. Supervisor Springer said the County was on as interim basis only so far and that they needed to start from the beginning. She said both sides were getting better but that the entities did not feel like they could input on the formation. Supervisor Davis spoke of the responsibility to the constituents and the duty to represent them and the inclusion of the other entities. He said that they needed to keep moving forward and said out

of this good work, others would see and join in. Supervisor Springer said the group still was not getting the message that the other entities see this as a "done deal" and that they would not join in without feeling like they had a part of the planning process. She said they should start with a clean slate and meet with the stakeholders and committee members to form rules and it would be up to the VRBP to make the case to represent all the work to have accepted, rejected or modified and that it should be the partnership that makes the rules, not non-voting members and public. Mayor Von Gausig said the last meeting in Camp Verde was that meeting. Supervisor Springer pointed out the definition of stakeholders was under Title 2.
