The above matter having come on regularly for hearing in accordance with law and the petition for the establishment of a highway for Yavapai County, as hereinafter described, having been fully considered, and all opposition, objections, demands and claims for compensation and all evidence relevant thereto having been heard; and

It appearing to the Board of Supervisors that said petition for the establishment of said highway should be granted and the establishment of said highway ordered, and said being the judgment of this board;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, State of Arizona, that the petition for the establishment of the highway as hereinafter described be granted, and that said highway be established and that this resolution be recorded in the Minutes of this Board.

BE IT FURTHER ORDERED that all lands, estate, interest, or thing described, as prayed for in said petition, be and the same are hereby condemned and appropriated to public use.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto Goldie Sutton, claimant herein, in the sum of One Dollar (\$1.00) as full compensation for property taken hereunder, and as payment for all damages accruing to said claimant by reason of these proceedings.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto Mrs. Susie Brown and husband, claimants herein, in the sum of One Hundred Dollars (\$100.00) as full compensation

for property taken hereunder, and as payment for all damages accruing to said claimants by reason of these proceedings.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto Vernon C. Bailes and Mary Bailes, his wife, claimants herein, in the sum of One Dollar (\$1.00) as full compensation for property taken hereunder and as payment for all damages accruing to said claimants by reason of these proceedings.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto Mrs. Nina Ritter, claimant herein, in the sum of One Dollar (\$1.00) as full compensation for property taken hereunder, and as payment for all damages accruing to said claimants by reason of these proceedings.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto Mrs. Lillie Churchill, claimant herein, in the sum of Twenty-seven and 48/100 Dollars (\$27.48) as full compensation for property taken hereunder and as payment for all damages accruing to said claimant by reason of these proceedings.

IT IS FURTHER ORDERED that an award be and the same is hereby made unto J. W. Dawson and wife, claimants herein, in the sum of Thirty-six and 75/100 (\$36.75) as full compensation for property taken hereunder, and as payment for all damages accruing to said claimants by reason of these proceedings.

Said highway which is hereby ordered established has a beginning, a terminus and general course of direction as follows:

Beginning at the junction of the Iron Springs and Williamson Valley Roads, near the Southeast Corner of Section Nineteen (19), Township Fourteen (14) North of Range Two (2) West; thence in a Northerly direction 1.5 miles, more or less, to the Bridge over Willow Creek on the Prescott-Williamson Valley Road.

Said highway is more particularly described on the map of said highway, which map has been filed herein and is annexed hereto.

IT IS FURTHER ORDERED that the record of this judgment, together with the said map of the said highway, be filed in the office of the County Recorder of Yavapai County, State of Arizona, said County being the County wherein the said highway is located.
