The above matter having come on regularly for hearing on the 18th day of July, 1949, having been set for said date by the Board of Supervisors, and said Board having fully considered all opposition, objections, demands, and claims for compensation and all evidence relevant thereto having been heard and considered; and

IT APPEARING TO THE BOARD OF SUPERVISORS that said petition for the establishment and altering of said highway as set forth in said petition should be granted and an order establishing, altering and designating said highway be entered herein, and that being the judgment of this Board;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the establishment and alteration of Cottonwood Hill Section of Kirkland-Yava Road, as hereinafter described, be granted and that said section of Kirkland-Yava Road be altered, designated and established as a public highway and that this resolution be recorded in the minutes of this Board as of this date;

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose

of the completion of said highway, be, and the same are,
hereby condemned and appropriated to public use; and,

IT IS FURTHER ORDERED that the following awards be,
and the same are, hereby made unto the following persons
as full compensation for all property taken hereunder and
as full payment for all damages accruing to said persons
by reason of these proceedings:

The said highway which is hereby ordered altered,
designated and established is described as follows with
reference to its beginning, terminus, and general course
of direction:

Beginning at a point in Section 17,
Township 13 North, Range 5 West, ap-
proximately seven miles northwest
of Kirkland, on the present Kirkland-
Yava Road;

Thence in a northwesterly and westerly
direction, through Sections 17, 18, 8
and 7, Township 13 North, Range 5 West,
and Section 12, Township 13 North, Range
6 West, approximately 3 miles to a
point in the present Kirkland-Yava Road;

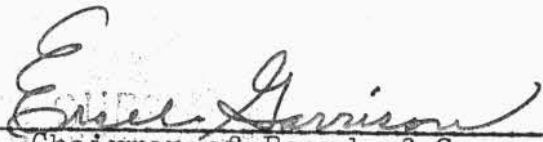
This alignment follows the present
county highway in a general way only,
improving sharp curves and reducing
steep grades.

the exact boundaries on both sides of said highway being
more particularly described on the map thereof in the
office of the County Engineer of Yavapai County, Arizona,
a copy of which map will be filed in the office of the
County Recorder of Yavapai County, Arizona, and reference

is hereby made to said map for a more particular description of said highway.

IT IS FURTHER ORDERED that the record of this judgment, together with the said map above referred to of said highway, be filed in the office of the County Recorder of Yavapai County, State of Arizona, said County being the county wherein the said highway is located.*
