The above matter having come on first to be heard on the 20th day of December, 1954, and having been set for final hearing on February 7, 1955, and all matters there presented having been duly heard by the Board of Supervisors, and said Board having fully considered all evidence relevant thereto; and

It appearing to the Board of Supervisors that the designating and establishing of the road from the New Black Canyon Highway connecting with Main Street, Humboldt, Yavapai County, Arizona, as set forth in said petition, is a public necessity and said petition should be granted, and an order designating and establishing said road be entered herein; and

It appearing to said Board of Supervisors that the Report of the Appraisers heretofore appointed in this matter is on file herein;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of the road from the New Black Canyon Highway connecting with Main Street, Humboldt, Yavapai County, Arizona, as hereinafter described, be granted, and that said road be designated and established as a public highway and that this resolution be recorded in the minutes of this Board as of this date; and

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose of the completion of said highway, be, and the same are hereby condemned and appropriated to public use; and

IT IS FURTHER ORDERED that the following awards be, and the same are hereby made unto the following persons as full compensation for all property taken hereunder and as full payment for all damages accruing to said persons by reason of these proceedings:

The said highway which is hereby ordered designated and established is described as follows with reference to its beginning, terminus, and general course of direction:

Beginning at a point in the center of Main Street, Humboldt, Engineers Sta. 2 + 88.73, a P.C. opposite the angle point in Lot 4, Block 3;

Thence on an 18° curve to the left, 174.07 ft. to a P.T., Sta. 4 + 62.80;

Thence N. 72° 28' W., 125.51 ft. to a P.C., Sta. 5 + 88.31;

Thence on a 3° curve to the left, 461.11 ft. to a P.T., Sta. 10 + 49.42; from which the SE corner of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 15, Township 13 North, Range 1 East, bears S. 58° 51' E., 120.0 ft. distant;

Thence N. 86° 15' W., 360.58 ft. to a point on the easterly Right of Way line of State Highway No. 69.

the exact boundaries on both sides of said highway being more particularly described on the map thereof in the office of the County Engi-

neer of Yavapai County, Arizona, a copy of which map will be filed in the office of the County Recorder of Yavapai County, Arizona, and reference is hereby made to said map for a more particular description of said highway.
