RESOLUTION OF ABANDONMENT

The above matter having come on regularly for hearing in accordance with law and the petition for the abandonment of a small portion of YUMA ROAD in the Hassayampa Mountain Club, Yavapai County, Arizona, as hereinafter described, and no persons appearing in opposition thereto, and the matter having been fully considered and all evidence relevant thereto having been heard, and

It appearing to the Board of Supervisors that said petition for the abandonment of a small portion of Yuma Road in the Hassayampa Mountain Club should be granted, and the same being the judgment of this Board,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, State of Arizona, that the petition for abandonment of a small portion of Yuma Road as hereinafter described, be granted and that this resolution be recorded in the Minutes of said Board as of this date; and

IT IS FURTHER ORDERED that the portion of Yuma Road to be abandoned, shall revert to and vest in the owners of the bounding and abutting property; and

IT IS FURTHER ORDERED that no compensation be paid to any person by reason of this action by said Board of Supervisors.

The said portion of Yuma Road in the Hassayampa Mountain Club which is hereby abandoned is described as follows, with reference to its beginning, terminus and general course of direction:

Beginning at the southwest corner of Lot 7, Block E, Plat C, Hassayampa Mountain Club, as recorded in the office of the Yavapai County Recorder.

Thence N. $41^{\circ}27'W.$, 90.70 ft;
Thence N. $32^{\circ}21'E.$, 23.63 ft;
Thence N. $10^{\circ}33'W.$, 43.96 ft;
Thence S. $32^{\circ}21'W.$, 77.70 ft;
Thence S. $41^{\circ}21'E.$, 113.50 ft;
Thence N. $48^{\circ}33'E.$, 27.83 ft;
Thence N. $77^{\circ}04'25"E.$, 2.47 ft. to a point of beginning.

IT IS FURTHER ORDERED that the record of this resolution, together with a map of said street, be filed in the office of the County Recorder of Yavapai County, State of Arizona, said county being the county wherein said Yuma Road is located.
