Beginning at the southeast corner of Lot12, Block A, Dixon Tract; Thence S. 89° 10' W, along the south line of Said Block B, to a point on the south line of Lot 5, Block B, opposite the most westerly corner of Lot 15, Block A, Plat C, Hassayampa Mountain Club; Thence S. 0° 50' E., 30 feet more or less to said most westerly corner of Lot 15; Thence N. 89° 06' E. along the north line of said Block A, to a point on the north line of Lot 8, Block A, opposite the point of beginning. Thence N. 0° 50' W., 30.0 feet to the point of beginning.
