RESOLUTION OF ESTABLISH-MENT FOR COUNTY CIGHWAY

PURPOSES

In re Public Hearing Concerning Petition for Designation and Establishing the Streets in Ashfork as County Roads of Yavapai County, State of Arizona.

The above matter having come on first to be heard on the 16th day of September, 1957, and having been set for final hearing on November 4, 1957, and all matters there presented having been duly heard by the Board of Supervisors, and said Board having fully considered all evidence relevant thereto, and,

It appearing to the Board of Supervisors that the designating and establishing of the Streets of Ashfork, as set forth in said petition, as County Roads, is a public necessity and said petition should be granted, and an order designating and establishing said road be entered herein; and,

It appearing to said Board of Supervisors that the report of the appraisers heretofore appointed in this matter is on file herein; that property owners herein will suffer no damages;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of the Streets of Ashfork as County Roads, as hereinafter described, be granted, and that said roadsbe designated and established as County Roads and that this resolution be recorded in the minutes of this Board as of this date; and,

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose of the completion of said highway, be, and the same are hereby condemned

and appropriated to public use; and,

IT IS FURTHER CRDERED that no compensation be paid to any person by reason of this action by said Board of Supervisors.

The said streets which are hereby designated and established are described as follows with reference to their beginning, terminus and general course of direction:

"2nd, 3rd, 4th and 5th Streets, between Lewis and Park Avenues in Ash Fork, Arizona, as shown on the plat of the town of Ash Fork, Yavapai County, Arizona, recorded on Page 2 in Book 2 of Maps and Plats, Yavapai County Recorder's Office.

The exact boundaries on both sides of said streets being more particularly described on the map thereof in the office of the County Engineer of Yavapai County, Arizona, a copy of which map will be filed in the office of the County Recorder of Yavapai County, Arizona, and reference is hereby made to said map for a more particular description of said streets.

IT IS FURTHER ORDERED that the record of this judgment, together with the said map above referred to of said streets, be filed in the office of the County Recorder of Yavapai County, Arizona, said county being the county wherein the said streets are located.
