RESOLUTION OF ESTABLISHMENT FOR COUNTY HIGHWAY PURPOSES

The above matter having come on first to be heard on the 3rd day of February, 1958, and having been set for final hearing on March 17th, 1958, and all matters there presented having been duly heard by the Board of Supervisors, and said Board having fully considered all evidence relevant thereto, and,

It appearing to the Board of Supervisors that the designating and establishing of 1st Street and Unnamed Street in Seligman, as set forth in said petition, as county roads, is a public necessity and said petition should be granted, and an order designating and establishing said roads be entered herein; and,

It appearing to said Board of Supervisors that the report of the appraisers heretofore appointed in this matter is on file herein; that property owners herein will suffer no damages;

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of 1st Street and Unnamed Street in Seligman as county roads, as hereinafter described, be granted, and that said roads be designated and established as county roads and that this resolution be recorded in the minutes of this Board as of this date; and,

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose of the completion of said highways, be, and the same are hereby condemned and appropriated to public use; and,

IT IS FURTHER ORDERED that no compensation be paid to any person by reason of this action by said Board of Supervisors.

The said streets which are hereby designated and established are described as follows with reference to their beginning, terminus and general course of direction:

"Beginning at the intersection of the center line of 2nd Street and the northerly right of way line of Chino Avenue; thence northerly 190 feet more or less to the northerly right of way line of an unnamed street. This county road to be 60 feet in width, 30 feet on each side of the above described center line.

Then beginning again at the intersection of the center line of said unnamed street and the easterly right of way line of 2nd Street; thence easterly 600 feet more or less along the center line of the unnamed street to the westerly right of way line of 1st Street. This county road to be 50 feet in width, 25 feet on each side of the above described center line.

Then beginning again at the intersection of said unnamed street with the westerly right of way line of 1st Street, as shown on the plat of Lamport Addition. This intersection being 5 feet northerly of the intersection of the center line of the unnamed street and the westerly right of way line of 1st Street described above. Thence easterly 483 feet more or less along the center line of the unnamed street to the westerly right of way line of Main Street. This county road to be 60 feet wide, 30 feet on each side of the above described center line."

The exact boundaries on both sides of said streets being more particularly described on the map thereof in the office of the County Engineer of Yavapai County, Arizona, a copy of which map will be filed in the office of the County Recorder of Yavapai County, Arizona, and reference is hereby made to said map for a more particular description of said streets.

IT IS FURTHER ORDERED that the record of this judgment, together with the said map above referred to of said streets, be filed in the office of the County Recorder of Yavapai County, Arizona, said county being the county wherein the said streets are located.
