RESOLUTION OF ESTABLISHMENT
FOR COUNTY HIGHWAY PURPOSES

The above matter having come on first to be heard on the 3rd day of March, 1958, and having been set for final hearing on April 21st, 1958, and all matters there presented having been duly heard by the Board of Supervisors, and said Board having fully considered all evidence relevant thereto, and

It appearing to the Board of Supervisors that the designating and establishing of the Streets in Yarnell, as set forth in said petition, as county roads, is a public necessity and said petition should be granted, and an order designating and establishing said roads be entered herein; and

It appearing to said Board of Supervisors that the report of the appraisers heretofore appointed in this matter is on file herein; that property owners will suffer no damages;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of the Streets in Yarnell, as county roads, as hereinafter described, be granted, and that said streets be designated and established as county roads and that this resolution be recorded in the minutes of this Board as of this date; and

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose of the completion of said county roads, be, and the same are hereby condemned and appropriated to public use; and

IT IS FURTHER ORDERED that no compensation be paid to any person by reason of this action by said Board of Supervisors.

The said streets which are hereby designated and established and described as follows with reference to their beginning, terminus and general course of direction:

"Oakway, as shown on Yarnell Heights Map No. 3, recorded in Book 4 of Maps at Page 10; beginning at U. S. Highway 89, and extending in a northwesterly and northeasterly direction 1,115 feet more or less, to an intersection with East Oakway.

Wall Street, as shown on a map of Saum Subdivision, recorded in Book 4 of Maps, at Page 45; beginning at U. S. Highway 89, and extending N. 59° 50' W., and N. 30° 10' E., 757 feet more or less, to an intersection with Oakway.

Table Top Way, as shown on an amended map of Yarnell, Plat C; recorded in Book 5 of Maps, at Page 4; beginning at U. S. Highway 89, and extending in a southeasterly direction 825 feet more or less.

Deer Way, as shown on an amended map of Yarnell, Plat C; recorded in Book 5 of Maps, at Page 4; beginning at U. S. Highway 89, and extending in a southeasterly direction 950 feet more or less."

The exact boundaries on both sides of said streets being more particularly described on the map thereof in the office of the County Engineer of Yavapai County, Arizona, a copy of which map will be filed in the office of the County Recorder of Yavapai County, Arizona, and reference is hereby made to said map for a more particular description of said streets.

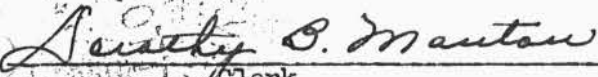
