RESOLUTION FOR ABANDONMENT

The above matter having come on regularly for hearing in accordance with law and the petition for the abandonment of the certain streets and roadways of Chavez Heights Subdivision, Yavapai County, Arizona, as hereinafter described, and no persons appearing in opposition thereto, and the matter having been fully considered and all evidence relevant thereto having been heard, and

It appearing to the Board of Supervisors that said petition for the abandonment of the certain streets and roadways of Chavez Heights Subdivision, should be granted, and the same being the judgment of this Board,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, State of Arizona, that the petition for abandonment of the certain streets and roadways, Chavez Heights Subdivision, as hereinafter described, be granted and that this resolution be recorded in the Minutes of said Board as of this date, and

IT IS FURTHER ORDERED that the certain streets and roadways of Chavez Heights Subdivision, which are hereby abandoned, shall revert to and vest in the owners of the bounding and abutting property; and

IT IS FURTHER ORDERED that no compensation be paid to any person by reason of this action by said Board of Supervisors.

The said certain streets and roadways, Chavez Heights Subdivision, which are hereby abandoned are described as follows, with reference to their beginning, terminus and general course of direction:

"Chavez Heights Subdivision in the County of Yavapai, being in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 25, SW $\frac{1}{4}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$; S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, of Section 24, and NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, T.17N., R.5E., G&SRB&M, Yavapai County, Arizona, and recorded in Book 5 of Maps and Plats, at page 75, records of Yavapai County, Arizona.

IT IS FURTHER ORDERED that the record of this Resolution, together with a map of said streets and roads, be filed in the office of the County Recorder of Yavapai County, State of Arizona, said county being the county wherein all the certain streets and roadways of Chavez Heights Subdivision are located.
