RESOLUTION OF ESTABLISHMENT FOR COUNTY HIGHWAY PURPOSES

The above matter having come on first to be heard on the 7th day of July, 1958, and the final hearing of said matter having been set for the 18th day of August, 1958, and all matters there presented having been duly heard by the Board of Supervisors, and said Board having fully considered all opposition, objections, demands and claims for compensation, and having duly considered the matter; and

IT APPEARING TO THE BOARD OF SUPERVISORS that said petition for the establishment and altering of said highway as set forth in said petition should be granted and an order establishing, altering and designating said highway be entered herein, and that being the judgment of this Board;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the establishment and alteration of the road from Skull Valley 4.1268 miles toward Kirkland, Yavapai County, Arizona, as hereinafter described, be granted, and that said road be altered, designated and established as a public highway and that this resolution be recorded in the minutes of this Board as of this date; and

BE IT FURTHER RESOLVED that all property, easements, and all interests therein, as described and set forth in said petition, or which may be necessary for the purpose of the completion of said highway, be, and the same are, hereby condemned and appropriated to public use; and

The said highway which is hereby ordered altered, designated and established is described as follows with reference to its beginning, terminus, and general course of direction:

Beginning at Engineer's Station 989+52, a P.O.C., on the easterly Right of Way line of the A. T. and S. F. Railway, from which the north One-Quarter Section Corner of Section 4, Township 13 North, Range 4 West, Gila and Salt River Base and Meridian, bears N. 53° 59' 30" W., 266.59 feet distant;

Thence on a  $6^{\circ}$  curve to the right, 1,142.51 feet to P.T., Station 1000+94.51;
