RESOLUTION NO. 42

RESOLUTION OF ESTABLISHMENT FOR COUNTY HIGHWAY PURPOSES

WHEREAS, on July 2, 1962, a petition in proper form was received by the Board of Supervisors of Yavapai County, Arizona, requesting establishment of a road beginning at the intersection of the Phoenix Cement Company road with U. S. Highway No. 89-A and extends 4.049 miles to an intersection with U. S. 89-A, south of Smelter City, and,

WHEREAS, the County Engineer did recommend the establishment of the road as a County Road under date of August 7, 1963, and,

WHEREAS, it appears to the Board of Supervisors that the designating and establishing of Bridgeport-Clarkdale Road Cottonwood By Pass, Yavapai County, Arizona, is a public necessity and in the public interest;

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Yavapai County, Arizona, that said Bridgeport-Clarkdale Road Cottonwood By Pass hereinafter described is hereby designated and established as a County Road and that this Resolution be recorded in the minutes of this Board as of this date.

The said road which is hereby designated and established is described as follows with reference to its beginning, terminus and general course of direction:

The road as surveyed begins at the intersection of the Phoenix Cement Company road with U. S. Highway No. 89-A and extends in a southeasterly direction 4.049 miles to an intersection with U. S. 89-A, traversing the following sections:

Section 19, Township 16 North, Range 3 East
" 30, " " " " " "
" 29, " " " " " "
" 32, " " " " " "
" 33, " " " " " "
" 4, Township 15 North, Range 3 East
" 2 & 3, " " " " " "

IT IS FURTHER ORDERED that this Resolution with said map above referred to of said road, to be filed in the office of the County Recorder of Yavapai County, Arizona, said County being the County wherein said road is located.
