RESOLUTION NO. 134
ESTABLISHING A COUNTY
HIGHWAY

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on the 16th day of September, 1968, pursuant to legal notice thereof and the Board having fully considered all matters in relation to the feasibility, advantage and necessity of the highway sought to be established and it appearing to the Board of Supervisors that the designating and establishing of the county highway as is herein described and is set forth in said petition as a county highway is a public necessity and that said petition for the establishment of said county highway should be granted and that said petition should be approved and that the Board by resolution shall approve the establishment thereof.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of a county road as hereinafter described be granted and that said road as hereinafter described be designated and established forthwith as a county road and that this resolution be recorded in the minutes of this Board as of this date.

IT IS FURTHER RESOLVED that all property, easements, and interests therein as described and set forth in said petition or which may be necessary for the purpose of the completion of said highway be, and the same is hereby, condemned and appropriated to public use.

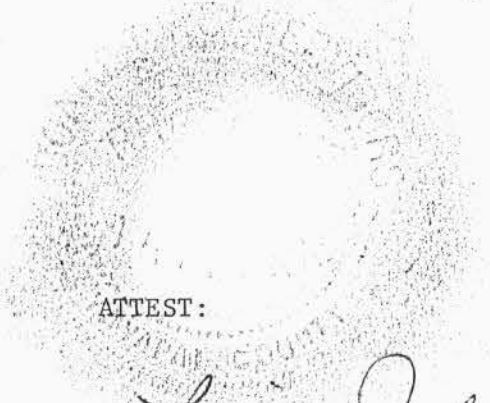
IT IS FURTHER RESOLVED that the legal description for the county road is hereby, condemned and appropriated to public use.

IT IS FURTHER RESOLVED that the legal description for the county road is hereby designated and established and is described as follows:

Country Park Drive, Robbie Lane, Pine Cove Road and
Sylvan Drive; Country Park Drive, beginning at a
point on the westerly right of way line of Willow
Creek Road and running westerly to Robbie Lane;
thence westerly along Robbie Lane to Pine Cove Road;
thence north along Pine Cove Road to Sylvan Drive;
thence westerly on Sylvan Drive to the easterly right
of way line of Williamson Valley Road, located in
Sections 17 and 20, Township 14North, Range 2 West.

The exact boundaries, course and distance on both sides of said
road being more particularly described on map thereof in the office
of the County Engineer of Yavapai County, Arizona, a duplicate copy of
which shall be filed in the office of the County Recorder of Yavapai
County, Arizona, reference to said maps being hereby made for a more
particular description.
