RESOLUTION NO. 240
ESTABLISHING COUNTY ROADS

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on the 19th day of June, 1972, pursuant to legal notice thereof and the Board having fully considered all matters in relation to the feasibility, advantage and necessity of the roads sought to be established as County Roads, and it appearing to the Board of Supervisors that the designating and establishing of the County Roads herein described and set forth in said petition as County Roads is a public necessity and that said petition for the establishment of said County Roads should be granted and that said petition should be approved and that the Board by resolution shall approve the establishment thereof.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the petition for the designating and establishing of County Roads as hereinafter described be granted and that said streets as hereinafter described be designated and established forthwith as County Roads and that this resolution be recorded in the minutes of this Board as of this date.

IT IS FURTHER RESOLVED that all property, easements, and interests therein as described and set forth in said petition or which may be necessary for the purpose of the completion of said roads, be, and the same is hereby, condemned and appropriated to public use.

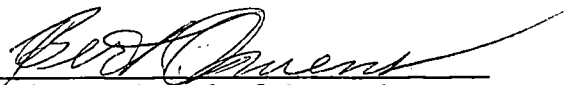
IT IS FURTHER RESOLVED that the legal description for the County Roads hereby designated and established and are described as follows:

1. Milton Avenue from Clubhouse Drive north to Canyon Drive.
2. Walnut Road from Clubhouse Drive north to Hoover Street.
3. Hoover Street from Walnut Road west to the end of Hoover.
4. Miramonte Drive from Bonita Drive north to Arena Drive.
5. El Camino Corvo.
6. La Corta Lane.
7. Granada Drive.
8. Monte Bello Lane.
9. East Skyview.
10. South Skyview from East Skyview Drive west to West Skyview Drive.
11. Boulder Drive from North Boulder Drive south to the end.
12. Estrella Road from Green Lane South and West to its intersection with Acorn Drive.
13. Chaparral Drive.
14. Shinnery Lane.
15. Palo Verde.
16. Pleasant Valley Circle.
17. Garden Lane.
18. Crest Way, Yarnell.

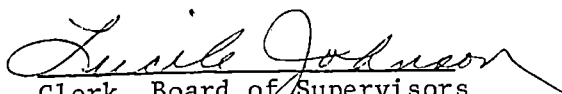
The exact boundaries, course and distance on both sides of said roads being more particularly described on map thereof in the office of the County Engineer of Yavapai County, Arizona, a
