

RESOLUTION NO. 247

A RESOLUTION CORRECTING AN ERROR IN  
THE DESCRIPTION OF AN ANNEXATION TO  
THE SELIGMAN VOLUNTEER FIRE DISTRICT

WHEREAS, on September 28, 1964 a petition was submitted to the Yavapai County Board of Supervisors for the annexation of certain territory to the Seligman Volunteer Fire District, and

WHEREAS, subsequently, after proper publication of notice on the date of March 8, 1965, an order of annexation was made by the Yavapai County Board of Supervisors under the following description:

Beginning at the NW corner of Section 6 T22N, R5W, G&SRB&M, Yavapai County, Arizona; thence easterly along the north line of said Section 6 to the NE corner of the NW 1/4 of the NW 1/4 of said Section 6 and true point of beginning of this description; thence easterly along said north line of said Sec. 6 to the NE corner of the NW 1/4 of NE 1/4 of said Sec. 6; thence southerly along the east line of the W 1/2 of the SE 1/4 of said Section 6 to its intersection with the north R/W line of the AT&SF R.R.; thence northwesterly along said R.R. R/W line to the intersection of west line of the E 1/2 of the NW 1/4 of said Section 6; thence northerly along said west line of the E 1/2 of the NW 1/4 to the point of beginning of this description,

and

WHEREAS, subsequently, a clerical error in the above description of the property to be annexed was discovered,

NOW, THEREFORE, BE IT ORDERED by the Yavapai County Board of Supervisors that the description of the property which was annexed to the Seligman Volunteer Fire District be hereby corrected to read as follows:

Beginning at the NW corner of Section 6 T22N, R5W, G&SRB&M, Yavapai County, Arizona; thence easterly along the north line of said Section 6 to the NE corner of the NW 1/4 of the NW 1/4 of said Section 6 and true point of beginning of this description; thence easterly along said north line of said Section 6 to the NE corner of the NW 1/4 of the NE 1/4 of said Section 6; thence southerly along the east line of the W 1/2 of the NE 1/4

of said Section 6 to its intersection with the north  
R/W line of the At&SF R.R.; thence northwesterly along  
said R.R. R/W line to the intersection of west line of  
the E 1/2 of the NW 1/4 of said Section 6; thence  
northerly along said west line of the E 1/2 of the NW  
1/4 to the point of beginning of this description.
