DeputyRESOLUTION NO. 378A RESOLUTION DECLARING THE DISSOLUTION OF
WILDWOOD ESTATES IMPROVEMENT DISTRICT

RESOLVED, by the Board of Supervisors of the County of
Yavapai, Arizona, that

WHEREAS, after proceedings undertaken pursuant to Article 1,
Chapter 5, Title 11, of Arizona Revised Statutes, as amended, this
Board did, on Monday, April 1, 1974, adopt a Resolution Declaring
Organized Wildwood Estates Improvement District; and

WHEREAS, the special assessment proceedings for the Wildwood
Estates Improvement District by the sale and issuance of bonds for
the purpose of providing public improvements to serve the property
within the Wildwood Estates Improvement District were never con-
summated; and

WHEREAS, the Wildwood Estates Improvement District is not
presently functioning in any capacity and the continuation of said
District will serve no purpose; and

WHEREAS, it is legally necessary and in the interest of the
public convenience, necessity and welfare that the Wildwood Estates
Improvement District be formally dissolved by this Board;

NOW, THEREFORE, IT IS FOUND, DETERMINED AND ORDERED, as
follows:

1. That the Wildwood Estates Improvement District be, and it

is hereby, formally dissolved by this Board, as required by Arizona statutes.

2. That the powers of a municipal corporation of the Wildwood Estates Improvement District, as a body corporate, previously granted, pursuant to Article 1, Chapter 5, Title 11, of Arizona Revised Statutes, as amended, be, and they are hereby revoked.
3. That the boundaries of said dissolved District are identified as those more particularly set forth in the Exhibit "A" attached hereto and made a part hereof as though set forth in full at this point.

BOUNDARIES OF DISTRICT

The coterminous exterior boundaries of the entire composite and consolidated territory consisting of:

(a) the proposed subdivision the plat of which is on file with the Clerk of the Board of Supervisors of Yavapai County, Arizona, and which was approved by said Board as a subdivision on March 4, 1974, entitled Wildwood Estates Unit IV, excepting Lots 97 through 104 and abutting streets and half-streets; and

(b) Lot 81, Wildwood Estates Unit III, and parcel to the north thereof, in Tract 40, Section 24, T 14 N, R 3 W, G.&S.R.B.&M., Yavapai County, Arizona, described as follows:

BEGINNING at the Northwest corner of Lot 81, WILDWOOD ESTATES, UNIT III, as recorded in Book 16 of Maps, page 29, Yavapai County Recorder's Office; thence North $23^{\circ}40'00''$ West, 104.90 feet; thence North $75^{\circ}54'00''$ East, 261.65 feet; thence South $44^{\circ}14'00''$ West, 57.70 feet; thence South $02^{\circ}00'00''$ West, 123.49 feet to the Northeast corner of said Lot 81; thence North $88^{\circ}18'00''$ West, 167.14 feet, along the North line of said Lot 81, to the POINT OF BEGINNING.
