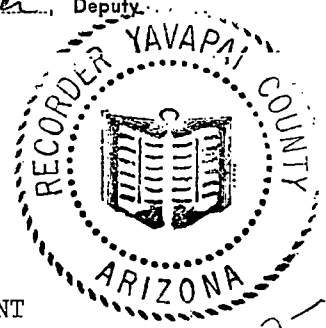

RESOLUTION OF ABANDONMENT

Resolution No. 468



The above matter regularly coming on before the Yavapai County Board of Supervisors at its regular meeting on June 1, 1981, on the petition of William W. and Patricia E. Knox requesting the abandonment of the herein-after described portion of Yavapai Road, as recorded on Map 3, Page 50, of Maps and Plats, Yavapai County Recorder's Office, from its intersection with Zuni Drive, to the southeast corner of Lot 1, Block D; thence northeasterly to the southwest corner of Lot 1, Block G, Hassayampa Mountain Club, Plat F, Yavapai County, Arizona, to vest in Parcels 107-1-61 and 107-1-71, adjacent properties, and the County Engineer has submitted a report and recommended the abandonment, and it appearing to the Board of Supervisors that the abandonment of a portion of such street will not leave any property without access to public roads and streets of Yavapai County, and the same should be granted.

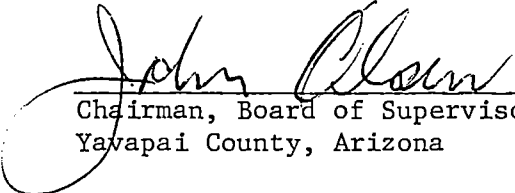
And it further appearing that due and regular notice of the proposed abandonment was duly and regularly given by publications of notice on May 15 and 22, 1981, and proof of such publications has been made and filed with the Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the request for abandonment of a portion of Yavapai Road, Hassayampa Mountain Club, Plat F, Yavapai County, Arizona, as described herein, and as shown on the attached Exhibit A, be and the same hereby is granted.

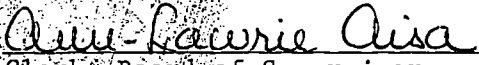
BE IT FURTHER RESOLVED that the vacated portion of a street shall vest in the adjacent properties, Parcels 107-1-61 and 107-1-71.
