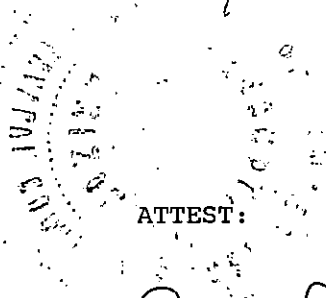
WHEREAS, such a plan must be approved by the Yavapai County Board of Supervisors; and

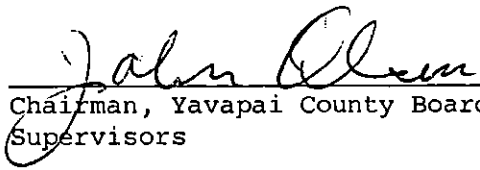

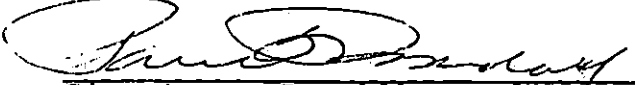
