RESOLUTION NO. 622

DESIGNATING AND ESTABLISHING SEVERAL STREETS IN CASTLE CANYON MESA
AND PRESCOTT EAST SUBDIVISIONS AS YAVAPAI COUNTY ROADS

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on October 15, 1984, pursuant to legal notice thereof, on the petition filed with the Board of Supervisors, and the Board determining that the establishment of the following roads:

1. Prescott East Highway from State Highway 69 north to the end.
2. Copper Hill Drive from the west line of Kings Highway West to the west line of Starlite Drive.
3. Sunset Lane from the west line of Castle Drive to the west line of Starlite Drive.
4. Date Creek Drive, from the north line of Copper Hill Drive to the west line of Starlite Drive.
5. Cedar Springs Lane from the north line of Copper Hill Drive to the south line of Sunset Lane.
6. Indian Wells Drive from the north line of Copper Hill Drive to the west line of Starlite Drive.
7. Kings Highway South from the east line of Kings Highway West to the west line of Kings Highway East.
8. Kings Highway West from the north line of Copper Hill Drive to the north line of Queen Street.
9. Kings Highway East from Kings Highway South to Kings Highway North.

10. Kings Highway North from the east line of Queen Street to the west line of Kings Highway East.
11. Queen Street from the east line of Kings Highway West to the south line of Sunset Lane.
12. All of Lancelot Avenue.
13. All of Jousts Avenue.
14. All of Duke Avenue.
15. Tower Road from the north line of Sunset Lane to the south line of Antelope Lane.
16. All of Parapet Circle.
17. All of Turret Circle.
18. Antelope Lane from the west line of Tower Road to the West line of the Prescott East Highway.

as County roads is a public necessity, having fully considered the feasibility, advantages, and necessity of their establishment.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the above mentioned roads in Castle Canyon Mesa and Prescott East Subdivisions as recorded in Book 12, page 2; Book 13, page 64; Book 16, page 48; Book 16, page 49; and Book 16, page 50, of Maps and Plats in the office of the Yavapai County Recorder, and as shown on the attached Exhibit A be designated and established forthwith as County roads.

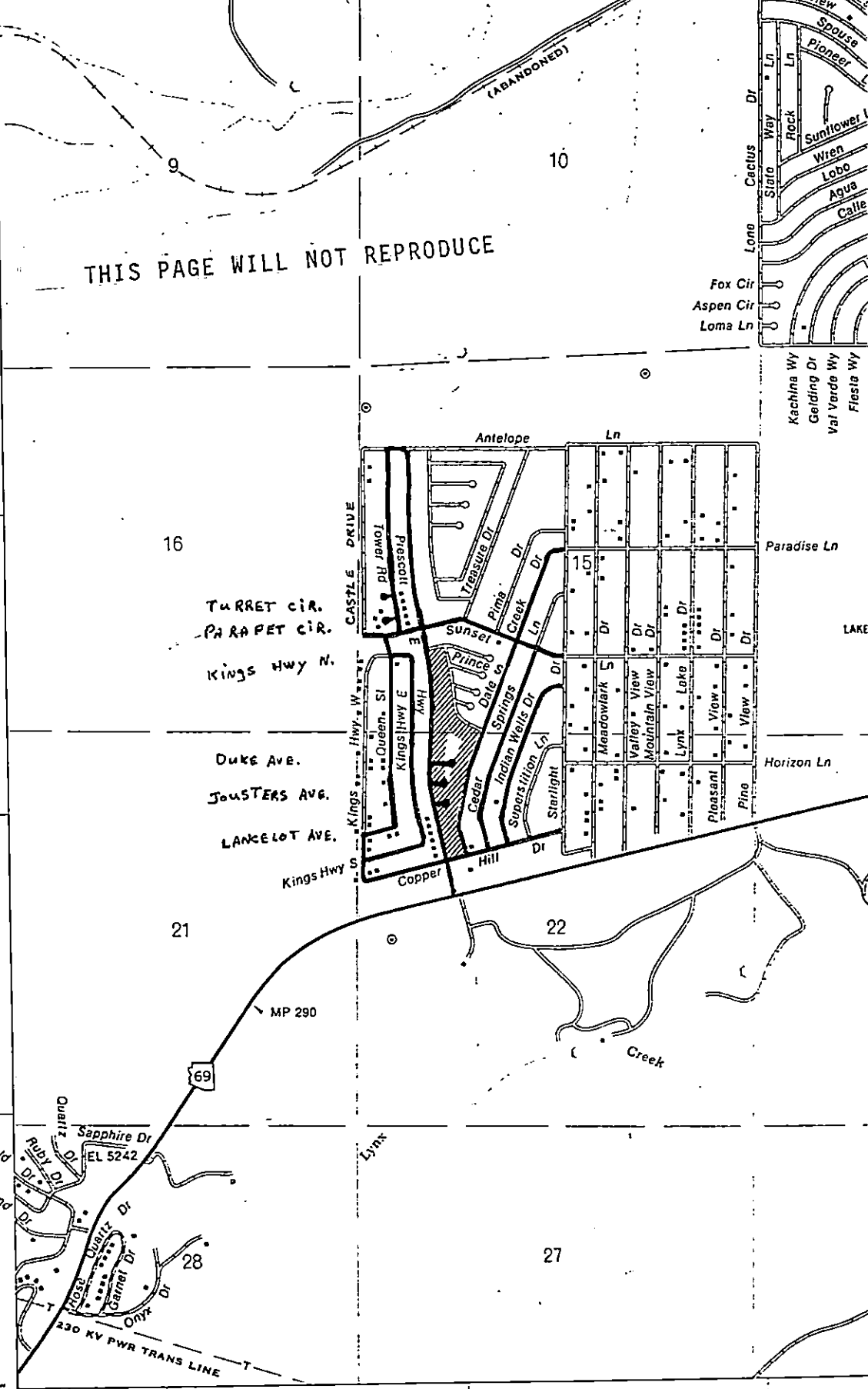
