RESOLUTION NO. 673

ESTABLISHING SEVERAL STREETS AND ROADS AS COUNTY HIGHWAYS

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on March 10, 1986, pursuant to legal notice thereof, at the request of the County Engineer and the petition filed with the Board of Supervisors, and the Board determining that the establishment of the following roads as County highways is a public necessity, having fully considered the feasibility, advantages, and necessity of their establishment:

- ARNOLD STREET as dedicated on the Plat of Camp Verde Townsite, and as recorded in Book 2 Page 62 of Maps and Plats, beginning at its intersection with Fifth Street easterly to its intersection with Main Street.
- 2. BRADSHAW ROAD as dedicated on the Plat of Lazy River Acres and as recorded in Book 7 Page 5 of Maps and Plats, beginning at its intersection with Green Valley Way; thence easterly to its intersection with Sleepy Acre Lane.
- 3. COCHISE DRIVE as dedicated on the Plats of Wickiup Mesa, Units One and Two, and as recorded in Book 6 Page 53 and Book 9 Pages 14 and 15, of Maps and Plats, beginning at its intersection with Navajo Road; thence westerly to its intersection with Pine Drive.
- 4. FOOTHILL DRIVE as dedicated on the Plats of: Sierra Dells, Command Estates Unit Two, Indian Castles, and Rancho Hi Meadows subdivisions, and as recorded in: Book 17 Page 2; Book 22 Page

35; Book 24 Page 35; Book 21 Pages 70 and 71; and Book 21 Page 23; respectively of Maps and Plats, beginning at its intersection with Trails End, Sierra Dells; thence northerly to its intersection with Knoll Circle, Rolling Ridge Ranches; thence that portion as dedicated and recorded in Book 22 Page 35 of Maps and Plats, beginning at its intersection with Knoll Circle; northerly to its intersection with State Highway 169.

- 5. GREEN VALLEY WAY as dedicated on the Plat of Lazy River Acres and as recorded in Book 7 Page 5 of Maps and Plats, beginning at its intersection with Lazy River Drive; thence northerly to its intersection with Bradshaw Road.
- 6. IRON SPRINGS ROAD (Prescott-Kirkland Highway FAS 255) That portion as recorded in Book 4 Page 80, Book 19 Pages 50 and 51 of Maps and Plats, starting from Station 0+00 in the southeast corner of Section 16 T14N R3W, G&SRB&M, thence northwesterly and southeasterly to PT 289+67.49 in Section 11 T15N R4W, G&SRB&M, a distance of approximately 4.5 miles.
- 7. KIRKLAND TO HILLSIDE JUNCTION ROAD (FAS 258) That portion of Kirkland to Hillside Junction Road as recorded in Book 10 Page 24 of Maps and Plats, beginning at Kirkland at station 0+12.34 in Section 31 T13N R4W, G&SRB&M; thence northerly to station 214+90.11 in Section 22 T13N R5W, G&SRB&M, a distance of approximately 4.07 miles.
- 8. KIRKLAND TO KIRKLAND JUNCTION ROAD As recorded in Book 11 Pages 95 and 96 of Maps and Plats, beginning at Kirkland in Section 6 T12N R4W, G&SRB&M, at POT 0+00; thence southeasterly to Kirkland Junction in Section 22 T12N R4W, G&SRB&M, ending at its intersection with U.S. Highway 89 in Section 22 T12N R4W, G&SRB&M, a distance of approximately 4.25 miles. This description includes the north wye and the south wye.
- 9. LANE STREET as dedicated on the Plats of Camp Verde Townsite, and Verde Hills, and as recorded in Book 2 Page 62 and Book 7 Page 20 respectively of Maps and Plats, beginning at Seventh Street, Verde Hills; thence easterly to its intersection with Main Street, Camp Verde Townsite; thence that portion, as it exists on the ground, running easterly through Block 2 of unrecorded Revised Camp Verde Townsite, and Blocks 18, 16 and 17 of unrecorded Military Reserve Addition of the Camp Verde Townsite, Camp Verde, Arizona, maps on file in the Yavapai County Engineer's Office, to its terminus in Section 32 T14N R5E, G&SRB&M.

- 10. LAZY RIVER DRIVE as dedicated on the Plat of Lazy River Acres and as recorded in Book 7 Page 5 of Maps and Plats, beginning at the point where Prescott Street ends, as dedicated on the Plat of Additional Survey of the Wells' Addition to the Town of Humboldt, as recorded in Book 2 Page 63 of Maps and Plats; thence easterly to its intersection with Green Valley Way.
- 11. PINE DRIVE as dedicated on the Plat of Wickiup Subdivision, Unit Two, and as recorded in Book 9 Page 14, and Montezuma Park Unit 7, as recorded in Book 9 Page 11 of Maps and Plats, beginning at its intersection with Cochise Drive; thence northerly to its intersection with Cliffside Trail.
- 12. SENATOR HIGHWAY (FAS 256 Prescott-Groom Creek Highway) That portion of Senator Highway as shown on right-of-way Map 14-H-3 on file in the Yavapai County Engineer's Office, beginning at station 0+80.63 in Section 26 T13N R2W, G&SRB&M; thence southerly to station 94+00 in Section 35 T13N R2W, G&SRB&M, at the Wolf Creek Junction, a distance of approximately 2 miles.
- 13. SLEEPY ACRE LANE, as dedicated on the Plat of Lazy River Acres, as recorded in Book 7 Page 5 of Maps and Plats, beginning at its intersection with Bradshaw Road; thence northerly to its intersection with Trails End in Sierra Dells, as recorded in Book 17 Page 2.

All above stated recordations are on record at the Yavapai County Recorder's Office in Prescott, Arizona.

NOW, THERFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the above described roads, and as shown on the attached Exhibit A, be designated and established forthwith as County highways.
