RESOLUTION NO. 682

OFFICIALLY NAMING STREETS IN
HIGHLAND PINE PROPERTIES AND HIGHLAND PINES

WHEREAS, a request has been received by the Yavapai County Board of Supervisors from the Highland Pine Property Owners Association and the County Engineer to officially name the following unnamed, but dedicated streets, in Highland Pine Properties Plat C, Highland Pines Plat F, Highland Pines Plat G Amended, Highland Pines Plat H, and Highland Pines Plat I Subdivisions, Yavapai County, Arizona:

CHINO VIEW, lying between Lots 35 and 36; DOUBLE EAGLE ROAD, lying between Lots 61 and 62; SLEEPY HOLLOW CIRCLE, lying between Lots 45, 53, 54, and 55, all in Highland Pine Properties Plat C Subdivision, as recorded in Book 6 page 52 of Maps and Plats, in the office of the Yavapai County Recorder; CEDAR COVE, lying between the easterly property line of Lot 17, a portion of the northerly property line of Lot 16, and the westerly property line of an exception to the subdivision; NAVAJO WAY, lying between the northerly property line of Lot 15, the northwesterly 166.87 feet of the westerly property line of Lot 7, the westerly property line of Lot 6, the easterly property line of Lots 4, 5, and the southwesterly property line of Lot 18; COCOPAH ROAD, lying between the easterly property line of Lot 18, the easterly property line of an exception to the subdivision, the southwest 280.57 feet of the westerly property line of Lot 3, and the westerly property line of Lot 5; SUNRISE DRIVE, beginning with its intersection with Sky Line Drive, Highland Pine Properties Plat C, thence southeasterly and adjacent to the northeasterly property line of Lot 19, thence easterly and adjacent to the northerly property line of an exception to the subdivision, thence northeasterly and adjacent to the northwesterly property line of Lot 18, and ending at the southerly property line of an exception to the subdivision, thence beginning northeasterly from the northeasterly property line of said exception, thence adjacent to the easterly property line of an exception to the subdivision and adjacent to the southerly property line of Lot 1, the westerly property line of Lot 2, and the northwest 162.34 feet of the westerly property line of Lot 3; thence southwesterly to a point on the northeasterly property line of the exception; HAPPY VALLEY CIRCLE, lying between Lots 1 and 2; MADIZELL DRIVE, from the southeasterly subdivision boundary and adjacent to the southeast corner of Lot 10, thence northerly adjacent to the easterly subdivision boundary, to the northerly subdivision boundary; PINON PINE ROAD, running between the easterly property line of Lots 13, 14, 15, the southwest 280.10 feet of the westerly property line of Lot 7, the westerly property line of Lot 8, the southwesterly property line of Lot 9, and the westerly property line of Lot 12; APACHE WAY, lying between Lots 9, 11, and 12, all in Highland Pines Plat

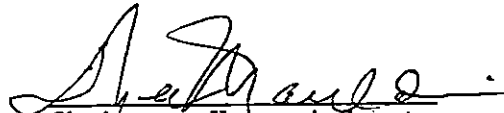

F, as recorded in Book 12 page 82 of Maps and Plats, in the office of the Yavapai County Recorder; PAPAGO ROAD, beginning at the southerly property line of Lot 19, and running southerly between and adjacent to the westerly property line of Lots 15 & 13, and the easterly property line of Lot 16, and the exception to the subdivision, and the northeasterly property line of Lot 17, this described portion in Highland Pines Plat F Subdivision; thence southwesterly and lying between Lots 10, 9, and 8, Highland Pines Plat I Subdivision, as recorded in Book 17 page 83 of Maps and Plats in the office of the Yavapai County Recorder; ZUNI LANE, running northwesterly between Lots 33A, 26, 26A, 27, 28, 31A, and 33, Highland Pines Plat G Amended, as recorded in Book 14 page 94 of Maps and Plats in the office of the Yavapai County Recorder; HILLSIDE DRIVE, lying between Lots 2, 1, and 12, Highland Pines Plat H, as recorded in Book 16 page 24 of Maps and Plats in the office of the Yavapai County Recorder, and the Easement for right of way as recorded in Book 532 page 563 of Deeds in the office of the Yavapai County Recorder; and

WHEREAS, the Board of Supervisors recognizes that said streets have been known and referred to locally as described above;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the names of the above described streets be officially named.
