ESTABLISHING PORTIONS OF REED ROAD AND SHADOW VALLEY RANCH
ROAD AS COUNTY HIGHWAYS

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on May 11, 1987, pursuant to legal notice thereof, at the request of the County Engineer and the petition filed with the Board of Supervisors, and the Board determining that the establishment of the following roads as County highways is a public necessity, having fully considered the feasibility, advantages, and necessity of their establishment:

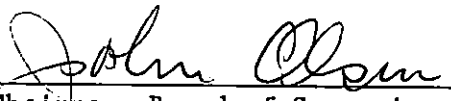
1. Reed Road as shown on the right of way map recorded in Book 26 Page 43 in the office of the Yavapai County Recorder, Prescott, Arizona, beginning at its intersection with Road 4 North; thence southerly to its intersection with Road 3 North, a distance of approximately one mile.
2. Shadow Valley Ranch Road as shown on the right of way map 14-I-1 on file in the office of the Yavapai County Engineer, beginning at its intersection with Williamson Valley Road on the north line of Section 19, T14N, R2W; thence westerly to PC 9+82.46, a distance of approximately .19 miles. Width of road to be 50 feet.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the above described roads, and as shown

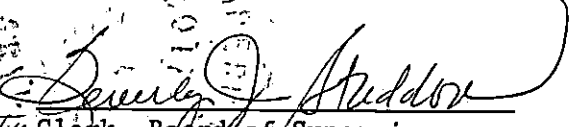
