WHEREAS, the existing name of Homanki is a misspelling of the Hopi Indian word Honanki;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the name of Homanki Circle, as described above and as shown on the attached Exhibit A, be changed to Honanki Circle.
