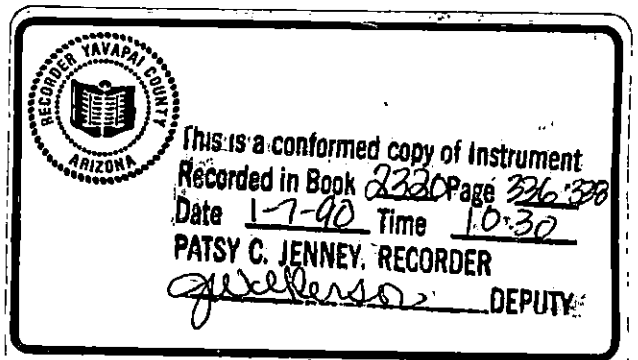




RESOLUTION NO. 829

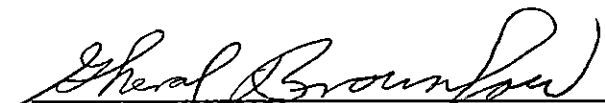
WHEREAS, certain County rights-of-way as further described in Exhibit "A" are adjacent to the City of Prescott;

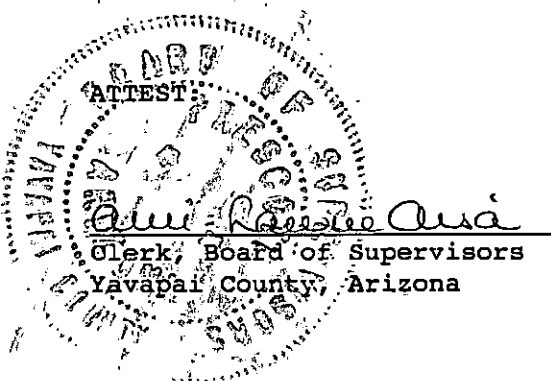

THENCE S. 46° 31' 46" W. a distance of 114.28 feet;

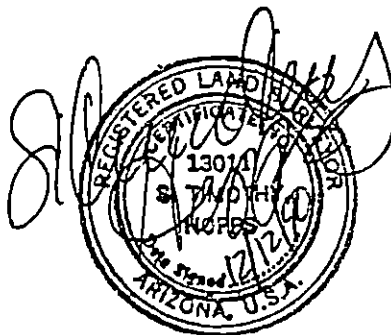
THENCE N. 33° 52' 27" E. a distance of 114.11 feet;

CONTAINING 0.3974 acres, more or less.



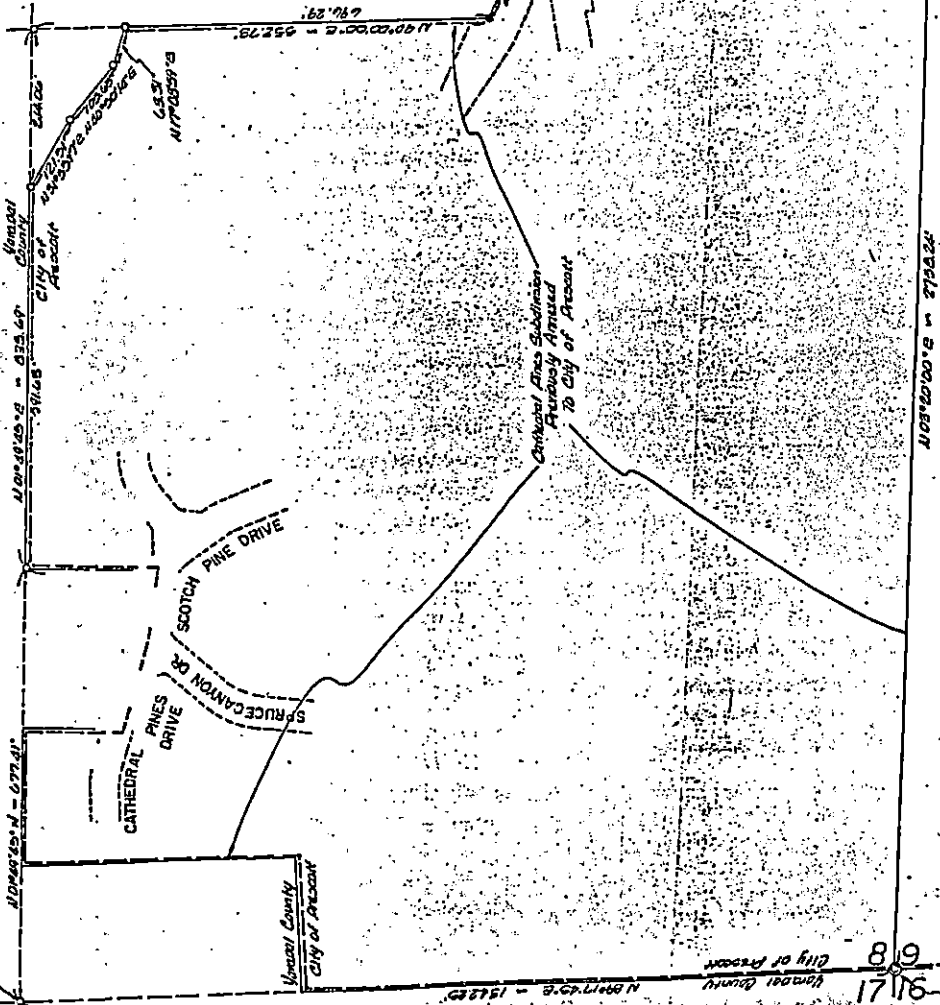
