

RESOLUTION NO. 850

A RESOLUTION OF THE BOARD OF SUPERVISORS, YAVAPAI COUNTY,
ARIZONA, APPROVING THE APPLICATION FOR THE COTTONWOOD/CLARKDALE
AREA FEDERAL AID URBAN AREA AND DESIGNATING PROPERLY CLASSIFIED
ROUTES THEREIN FEDERAL-AID URBAN

WHEREAS, the City of Cottonwood, Town of Clarkdale, and Yavapai County have been requested by the Arizona Department of Transportation to designate their federal-aid urban system, and

WHEREAS, only those roads functionally classified as collectors, minor arterial, or principal arterial are eligible as federal-aid and urban routes, and

WHEREAS, the functional classification system of all roads within the urban boundary under the jurisdiction of the City of Cottonwood, Town of Clarkdale, or Yavapai County was completed;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS, YAVAPAI COUNTY, ARIZONA, THAT THE BELOW LISTED ROADS UNDER THE JURISDICTION OF THE CITY OF COTTONWOOD, TOWN OF CLARKDALE, OR YAVAPAI COUNTY, THAT ARE PROPERLY CLASSIFIED, BE DESIGNATED AS FEDERAL-AID URBAN.
