

RESOLUTION NO. 923

ESTABLISHING ALL ROADS IN PINE VALLEY AMENDED
SUBDIVISION AS COUNTY HIGHWAYS

This matter coming on to be heard before the Board of Supervisors of Yavapai County, Arizona, on May 23, 1993, pursuant to legal notice thereof, at the request of the homeowners' of Pine Valley Amended Subdivision and the petition filed with the Board of Supervisors, and the Board determining that the establishment of the following roads as County highways is a public necessity, having fully considered the feasibility, advantages, and necessity of its establishment:

DISTRICT 3:

BOBCAT CT., beginning at its intersection with Ridgecrest Drive, thence easterly to its terminus in a cul-de-sac.

BLAZING STAR TRAIL, formerly Sunset Drive, beginning at its intersection with Valley Vista Drive, thence northerly to its intersection with White Horse Way.

DEER CT., beginning at its intersection with Quail Hollow Drive thence westerly to its terminus in a cul-de-sac.

GRAY FOX DRIVE, formerly Rosewood Road, beginning at its intersection with Ridgecrest Drive, thence westerly to its terminus in a cul-de-sac.

JACKS CANYON ROAD, formerly Valley Vista Drive, beginning at its intersection with Gray Fox Drive, formerly Rosewood Road, thence southerly to the south subdivision boundary.

LONGWOOD DRIVE, beginning at its intersection with Valley Vista Drive, thence northerly to its intersection with Sedona Road, formerly Sedona Shadows Road.

MOUNTAIN ROAD, formerly Mountain Shadows Road, beginning at its intersection with Valley Vista Road, thence northerly to its terminus in a cul-de-sac.

QUAIL HOLLOW DRIVE, beginning at its intersection with Gray Fox Drive, formerly Rosewood Road, thence northerly to its intersection with Raintree Road.

RABBIT COURT, formerly Quail Court, beginning at its intersection with Quail Hollow Drive, thence westerly to its terminus in a cul-de-sac.

RAINTREE ROAD, beginning at its intersection with Quail Hollow Drive, thence southerly to its terminus in a cul-de-sac.

REDROCK CT., beginning at its intersection with Ridgecrest Drive, thence easterly to its terminus in a cul-de-sac.

RIDGECREST CT., beginning at its intersection with Ridgecrest Drive, thence easterly to its terminus in a cul-de-sac.

RIDGECREST DRIVE, beginning at its intersection with Gray Fox Drive, formerly Rosewood Road, thence northerly to its intersection with Redrock Ct.

SEDONA ROAD, formerly Sedona Shadows Road, beginning at its intersection with Valley Vista Drive, thence northerly to its intersection with Longwood Drive.

SPOTTED FAWN COURT, beginning at its intersection with Wild Flower Circle, thence southwesterly to its terminus in a cul-de-sac.

WHITE HORSE WAY, beginning at its intersection with, Sedona Road, formerly Sedona Shadows Road, thence easterly to its intersection with Valley Vista Drive.

WILD FLOWER CIRCLE, beginning at its intersection with, Gray Fox Drive, formerly Rosewood Road, thence northerly, thence westerly, thence southerly, thence southeasterly to its intersection with itself.


VALLEY VISTA DRIVE, beginning at its intersection with Ridgecrest Drive, thence northeasterly, to its intersection with White Horse Way.

All the above roads dedicated, in the Pine Valley Amended Subdivision, Book 19 pages 60 and 61 of Maps and Plats, in the office of the Yavapai County Recorder, Prescott, Arizona.

The above mentioned road name changes were approved by the Board of Supervisors by Resolutions Numbered 501, 703, and 835.


NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Yavapai County, Arizona, that the above described roads and portions of roads, and as shown on the attached Exhibit A and B, be designated and established forthwith as a County highways.
