

RESOLUTION NO. 1084

A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY AUTHORIZING THE SUBMISSION OF APPLICATIONS FOR FY 1997 STATE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, CERTIFYING THAT SAID APPLICATIONS MEET THE COMMUNITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENTS OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATION.

WHEREAS, Yavapai County is desirous of undertaking community development activities; and

WHEREAS, the State of Arizona is administering the Community Block Grant Program; and

WHEREAS, the State CDBG program requires that CDBG funds requested address one of the three Congressional mandated national objectives; and

WHEREAS, the activities within these applications address the community's identified housing and community development needs, including the needs of low and moderate income persons; and

WHEREAS, a grantee of State CDBG funds is required to comply with the program guidelines and Federal Statutes and regulations.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of Yavapai County authorizes application to be made to the State of Arizona, Department of Commerce for FY 1997 CDBG funds, and authorizes the Chairman of the Board to sign the applications and contract or grant documents for receipt and use of these funds for:

- Locate and procure an approximate 1,800 sq. foot building in Ash Fork for a health clinic.
- Install a water line and fire hydrant for fire safety in Ash Fork.
- Renovate the Beaver Creek Senior Center.

- Procure a communication system for the Black Canyon City Volunteer Fire Department.
- Support the staff salaries and operations of a Camp Verde Volunteer Fire Department.
- With volunteers, construct a warehouse for the Chino Valley Food Bank.
- With volunteers, to construct a senior center in Dewey-Humboldt.
- Acquire and prepare two lots for Habitat for Humanity to construct affordable homes.
- Construct an addition to the Mayer Community Center.
- With volunteers, construct a fire station and community center for Paulden.
- With volunteers, construct a fire house and community center for Peebles Valley.
- Procure a vehicle and fire fighting equipment for the Seligman Fire Department.
- With volunteers, to construct a fire house for Skull Valley.
- Acquire land and install a manufactured home in the Verde Valley to provide a transitional shelter for about victims of domestic violence.
- Renovate the Verde Valley Senior Center.
- Double Chip Seal and drainage work to approximately 6,000 feet of roads in Wilhoit.
- Renovate the Yarnell Senior Center.
- Procure a van to provide recreation and provide operations for adults with disabilities in the Verde Valley.

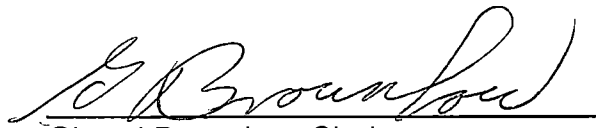
And to submit and fund back-up activities as conditions permit:

- American Red Cross Reserve-A-Ride - Procure or lease a van to transport elderly and disabled persons.
- Staffing and operations for the Community Legal Services to begin and office in Cottonwood to offer free legal services.
- Pave, curb, and gutter streets in the northeast Black Canyon City.

THAT this application for State CDBG funds meets the requirements of low and moderate-income benefit for activities justified as benefiting low and moderate income persons, or aids in the prevention or elimination of slum and blight or addresses an urgent need which poses a threat to health; and

THAT Yavapai County will comply with all State CDBG program guidelines, Federal Statutes and regulations applicable to the State CDBG program and the certifications contained in the application.
