

RESOLUTION NO. 1217

**CAMINO VISTA DRIVE (A PORTION OF) CHANGED TO ALBATROS ROAD
CAMINO VISTA DRIVE (A PORTION OF) CHANGED TO UNNAMED ROAD**

WHEREAS, a portion of Camino Vista Drive is not commonly known as Camino Vista Drive, but as Albatros Road and another portion of Camino Vista Drive is confusing to the public;

WHEREAS, a public hearing was set for the Board of Supervisors to consider changing a portion of Camino Vista Drive to the more commonly used roadway name of Albatros Road and a portion of Camino Vista Drive to Unnamed Road (an appropriate roadway name may be chosen at a later date);

WHEREAS, the portion of Camino Vista Drive proposed to be changed to Albatros Road is a county maintained right-of-way, recorded in Book 10 Page 47 of Maps and Plats, in the Rimrock Acres #3 subdivision and runs between existing Albatros Roads for approximately 920 feet;

WHEREAS, the portion of Camino Vista Drive proposed to be changed to Unnamed Road is a county maintained right-of-way, recorded in Book 10 Page 47 of Maps and Plats, in the Rimrock Acres #3 subdivision and runs south from Airport Drive for approximately 460 feet;

WHEREAS, the two referenced portions of Camino Vista Drive are not commonly known as Camino Vista Drive or used by the surrounding property owners / residents. By changing a portion of Camino Vista Drive to Albatros Road and a portion of Camino Vista Drive to Unnamed Road should not effect the surrounding property owners, but will reduce confusion for the Montezuma – Rimrock Fire Department, Rimrock Post Office, and the public.

WHEREAS, with the support of the County Engineering Department the Board of Supervisors will consider changing a portion of Camino Vista Drive to Albatros Road and a portion of Camino Vista Drive to Unnamed Road, as the area property owners, residents, and street signage do not recognize Camino Vista Drive for these referenced portions.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider changing a portion of Camino Vista Drive to Albatros Road and a portion of Camino Vista Drive to Unnamed Road, on February 22, 2000. A notice of this hearing was published in Verde Independent on February 16, 2000, posted along the roadway, and a notice was mailed to the adjacent property owners of the above described roadway, Montezuma – Rimrock Fire Department, Rimrock Post Office, Yavapai County Sheriff's Office, and other related agencies;

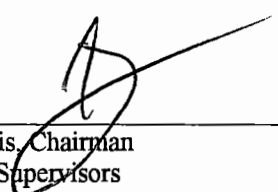
WHEREAS, a public hearing was held on February 22, 2000 to consider changing these referenced roadway names. No comment from the public was given, therefore the Board of Supervisors unanimously voted approval of the proposed change.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of Yavapai County declares a portion of Camino Vista Drive, as described above and illustrated on the attached exhibit A, be changed to Albatros Road.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of Yavapai County declares a portion of Camino Vista Drive, as described above and illustrated on the attached exhibit A, be changed to Unnamed Road.

These name changes shall become effective 60 days after the date approved by the Board of Supervisors
