ESTABLISHING SEVERAL ROADS AS COUNTY HIGHWAYS

ALCHISE DR., Wickiup Mesa Unit Three, as dedicated in Book 9 Page 82-84 of Maps & Plats, beginning at

Its intersection with Lavin Lane, thence southerly to the south subdivision boundary, thence continuing southerly through

Wickiup Mesa as dedicated in Book 6 Page 53 of Maps & Plats, thence southerly to its intersection with Geronimo Road,

thence beginning at its intersection with Valley Lane, Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of

Maps & Plats, thence southerly to its intersection with Cedar Dr. and as shown on Exhibit A.

CEDAR Dr., Wickiup Mesa Unit Two, as dedicated in Book 9 Pages 14-16 of Maps & Plats, beginning at its intersection with Forestglen Rd. (formerly known as Navajo Rd.), thence westerly to its intersection with Gold Canyon Way (formerly known as Birch Way) and as shown on Exhibit A.

GERONIMO ROAD, Wickiup Mesa, as dedicated in Book 6 Page 53 of Maps & Plats, beginning at its intersection with Forestglen Rd. (formerly known as Navajo Road), thence southwesterly, thence southwesterly through Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, thence northerly to its intersection with Cliffside Trail and as shown on Exhibit A.

GOLD CANYON WAY, Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, beginning at its intersection with Oswego St., thence southerly to its intersection with Redrock Dr. and as shown on Exhibit A.

NACHEZ DR., Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, beginning at its intersection with Oswego St., thence southerly to its intersection with Cedar Dr. and as shown on Exhibit A.

REDROCK DR., Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, beginning at its intersection with Gold Canyon Way (formerly known as Birch Way), thence easterly to its intersection with Forestglen Rd. (formerly known as Navajo Rd.) and as shown on Exhibit A.

VALLEY LANE, Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, beginning at its intersection with Forestglen Rd. (formerly known as Navajo Rd.), thence westerly, thence southwesterly to its intersection with Pine Dr. and as shown on Exhibit A.

WICKIUP DR., Wickiup Mesa, as dedicated in Book 6 Page 53 of Maps & Plats, beginning at its intersection with Cochise Drive, thence northerly, thence northerly through Wickiup Mesa Unit Two, as dedicated in Book 9 Page 14-16 of Maps & Plats, thence northeasterly to its terminus in a cul-de-sac, thence beginning at its intersection with Cedar Dr., thence northerly to its terminus in a cul-de-sac and as shown on Exhibit A.

KERRY DRIVE, Wickiup Mesa Unit Three, as dedicated in Book 9 Page 82-84 of Maps & Plats, beginning at its intersection with Nachez Dr., thence westerly, thence northerly to its intersection with Valancius Way and as shown on Exhibit A.











Exhibit B Lake Montezuma Area
