RESOLUTION NO. 1319

ADOPTION OF CONGRESS OFFICIAL STREET NAME MAP

WHEREAS, the Yavapai County Board of Supervisors were requested by Vincent A. Gallegos, Addressing / 9-1-1 Coordinator to adopt an official street name map for the Congress area

WHEREAS, the map illustrates existing and commonly known street names in the community;

WHEREAS, the map also illustrates and listed below are the new street names created by renaming confusing street names and naming previously unnamed streets;

Roadrunner Lane, in its entirety, beginning at its intersection with Quail Run, thence south to its termination, **changed to Thompson Court**, as shown on Exhibit A.

Bullard Drive, a portion of, beginning at its intersection with Bullard Drive and looping back to Bullard Drive, as dedicated and recorded in Book 17 Page 37 of Maps and Plats, **changed to Bullard Circle**, as shown on Exhibit A.

Old Schoolhouse Road, a portion of, as dedicated and recorded in Book 10 Page 37 of Maps and Plats, beginning at its intersection with Highway 71, thence southerly to its intersection with Sunrise Road, **changed to Santa Fe Road**, as shown on Exhibit B.

Old Schoolhouse Road, a portion of, beginning at its intersection with Sunrise Road, thence south to its intersection with the street newly named Hays Road, **changed to Santa Fe Road**, as shown on Exhibit B.

Old Schoolhouse Road, a portion of, running east/west, **changed to Hays Road**, as shown on Exhibit B.

Old Schoolhouse Road, a portion of & **Voyle Road**, beginning at its intersection with Sunrise Road, thence south to its intersection with Wellside Road, **changed to Old School Road**, as shown on Exhibit B.

WHEREAS, streets not previously officially named have been named **Deck Mine Road, Sullivan Drive, Jakes Way, Merit Way, and Jersey Trail**, as shown on Exhibit C.

WHEREAS, a street not previously officially named have been named **Alegria Lane**, as shown on Exhibit D.

WHEREAS, streets not previously officially named have been named **Scholar Lane, Senator Way, Coyote Trail, Mesquite Lane, Painted Acres, and Feather Lane**, as shown on Exhibit E.

The Official Street Name Map for the Congress area is recorded in Book 44 Pages 54 of Maps and Plats.

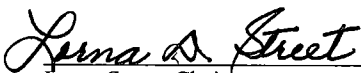
All above recordations are on file in the office of the Yavapai County Recorder, Prescott, Arizona.

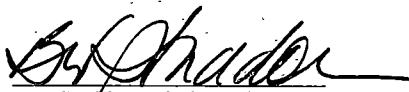
These name changes shall become effective 60 days after the date approved by the Board of Supervisors.

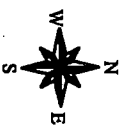


BULLARD CIRCLE

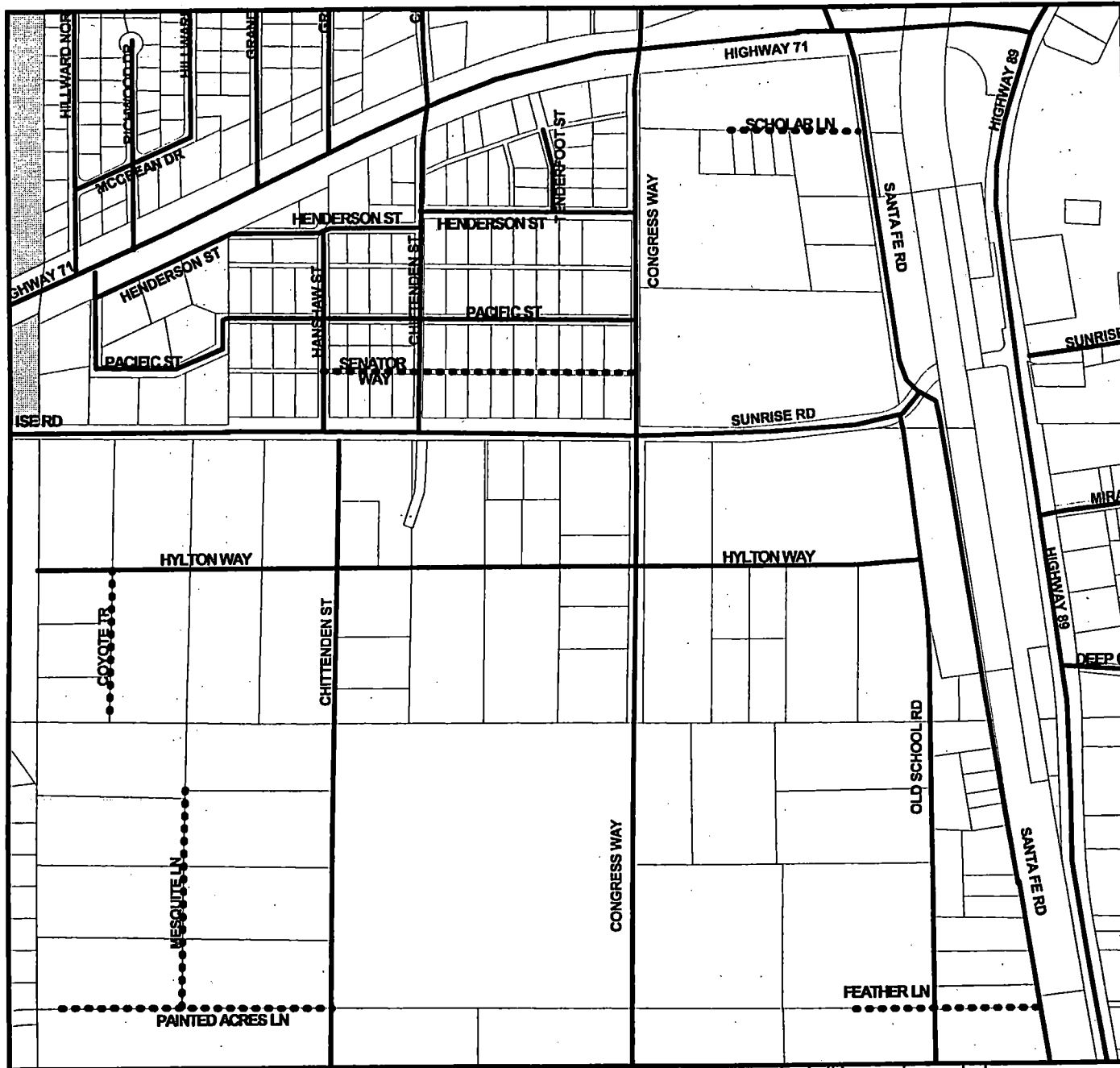
