RESOLUTION NO. 1333

PAULDEN / CHINO VALLEY RURAL ADDRESS PROJECT STREET NAME MAP (AMENDED)

WHEREAS, on April 2, 2001 the Yavapai County Board of Supervisors adopted the street name map for the Paulden / Chino Valley rural address project area;

WHEREAS, six (6) errors on the street name map were identified during phase II of the rural addressing project;

WHEREAS, in addition to the errors identified, the property owners along End of Trail petitioned Yavapai County to rename the street adjacent to their property to Stagecoach Pass;

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider resolving the errors and the petition for the street name change to End of Trail;

WHEREAS, a notice of hearing was printed in the Prescott Courier, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Chino Valley Fire Department, Paulden Volunteer Fire Department, Public Works Department, and the property owners adjacent to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing, received public comment at the public hearing, and voted unanimously to approve the following requested street name changes;

Wolf Den Lane, in its entirety, beginning at its intersection with Little Ranch Road, thence running south to its termination, **changed to an unnamed status**, as shown on exhibit A.

A portion of Moon Shadow, beginning at its intersection with Little Ranch Road, thence running south to its termination, **changed to Wolf Den Lane**, as shown on exhibit A.

An Unnamed Road, in its entirety, beginning at its intersection with Little Ranch Road, thence running south to its termination, **changed to Triple J Lane**, as shown on exhibit A.

Triple J Lane, in its entirety, beginning at its intersection with Little Ranch Road, thence running south to its termination, **changed to an unnamed status**, as shown on exhibit A.

Windmill Lane, in its entirety, beginning at its intersection with Little Ranch Road, thence running south to its termination, **changed to Windy Hill Lane**, as shown on exhibit A.

Latigo Lane, in its entirety, beginning at its intersection with Hackamore Lane, thence running west to its termination, **changed to Latigo Court**, as shown on exhibit B.

End of Trail, in its entirety, beginning at its intersection with Rocky Road, thence running north to its termination, **changed to Stagecoach Pass**, as shown on exhibit C.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of Yavapai County declares the above described and illustrated on the attached exhibits, be officially renamed.

The Amended Official Street Name Map for the Paulden / Chino Valley Rural Address Project area is recorded in Book 46 Pages 58-59 of Maps and Plats.

All above recordations are on file in the office of Yavapai County Recorder, Prescott, Arizona.

These name changes shall become effective 60 days after the date approved by the Board of Supervisors.

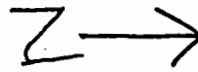

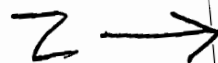
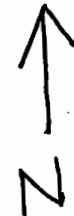
