RESOLUTION NO. 1367

MANZANITA TRAIL (a portion of) TO HEREFORD LANE

WHEREAS, in an effort to improve public safety, the Prescott Country Club Property Owners Association circulated a petition to rename a portion of Manzanita Trail to Hereford Lane;

WHEREAS, the Association obtained signatures from 11 of the 16 adjacent property owners supporting the renaming of the street;

WHEREAS, the referenced portion of Manzanita Trail is confusing to the public and emergency agencies, because it does not connect with a second existing portion of Manzanita Trail;

WHEREAS, the referenced portion of Manzanita Trail is alignment with the street known as Hereford Lane;

WHEREAS, the Association identified a logical plan by eliminating a portion of Manzanita Trail and extending Hereford Lane;

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming a portion of Manzanita Trail to Hereford Lane;

WHEREAS, a notice of hearing was printed in the Prescott Courier on August 25, 2002, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Central Yavapai Fire District, Public Works Department, and the adjacent property owners to the above referenced street;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on August 25, 2002;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the portion of Manzanita Trail as described above and as illustrated on the attached Exhibit A, be changed to Hereford Lane.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the street name change filing fee be waived as renaming this street is intended to improve public safety.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

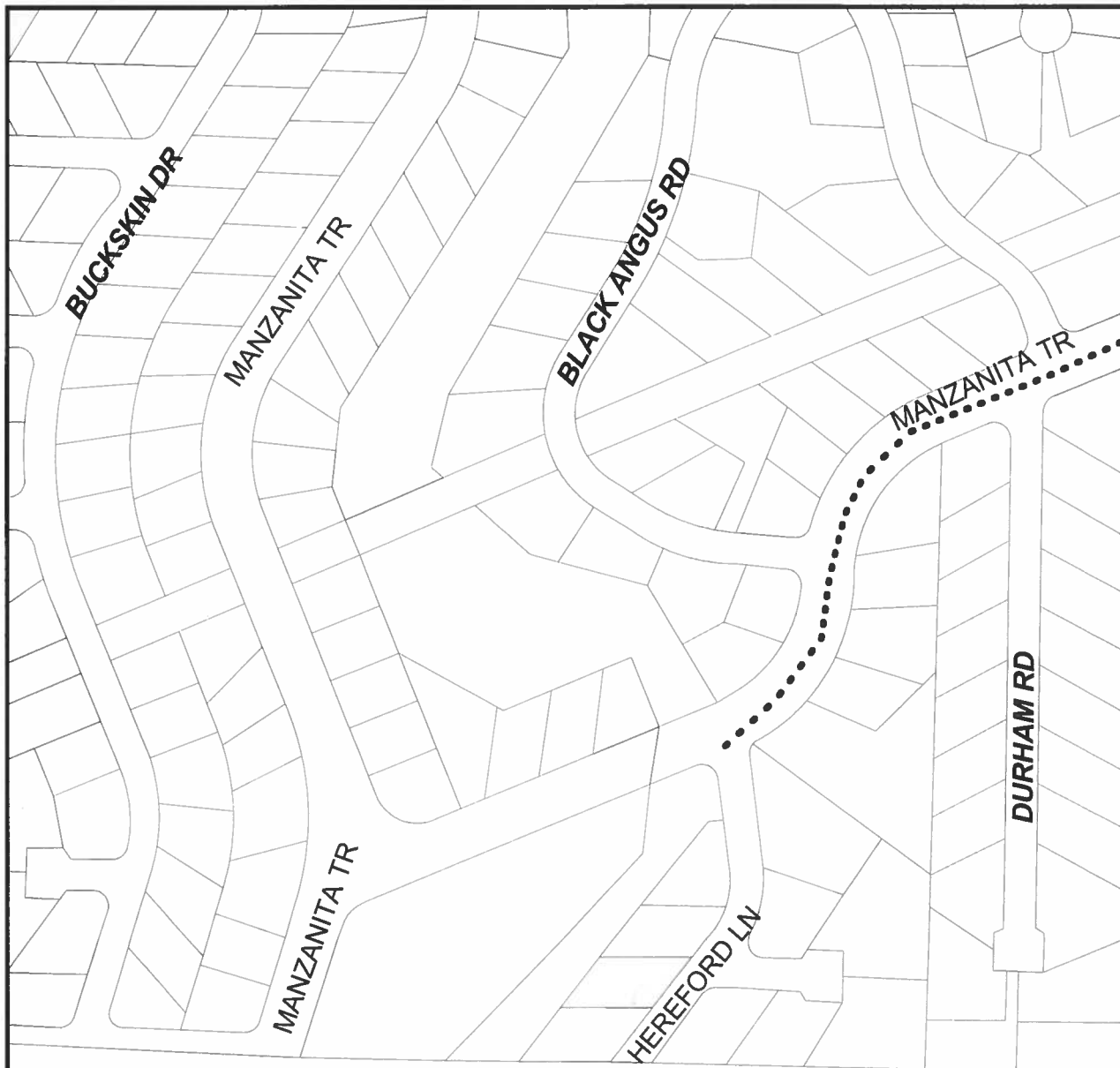
