RESOLUTION NO. 1410

**BUTTERFIELD ROAD (a portion of) TO OVERLAND ROAD
HILLCREST LANE TO BUTTERFIELD ROAD**

WHEREAS, Prescott Fire Department, Central Yavapai Fire District, and Vincent Gallegos, Addressing / 911 Coordinator met regarding the renaming of two streets, in the Prescott area;

WHEREAS, the requested street name changes are dedicated within the City of Prescott and Yavapai County;

WHEREAS, the requested street name changes will improve public safety;

WHEREAS, Butterfield Road is recorded on a plat, in Book 9 Page 79 of Maps and Plats and in Book 10 Page 74 of Maps and Plats, in the office of the Yavapai County Recorder;

WHEREAS, Hillcrest Lane is recorded on a plat of Green Manor Heights, in Book 4 Page 81 of Maps and Plats, in the office of the Yavapai County Recorder;

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming Butterfield Rd to Overland Rd and Hillcrest Lane to Butterfield Rd;

WHEREAS, a notice of hearing was printed in the Prescott Courier on August 24, 2003, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Prescott Fire Department, Central Yavapai Fire District, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on September 2, 2003;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that a portion of Butterfield Road as described above and as illustrated on the attached Exhibit A, be changed to Overland Road.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Hillcrest Lane as described above and as illustrated on the attached Exhibit A, be changed to Butterfield Road.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the street name change filing fee be waived as renaming this street is intended to improve public safety.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.
