RESOLUTION NO. 1436

ADOPTION OF SKULL VALLEY OFFICIAL STREET NAME MAP

WHEREAS, the Yavapai County Board of Supervisors were requested by Toni Hudson, Addressing / 9-1-1 Coordinator to adopt an official street name map for the Skull Valley area

WHEREAS, the map illustrates existing and commonly known street names in the community;

WHEREAS, the map also illustrates and listed below are the new street names created by renaming confusing street names and naming previously unnamed streets;

Prescott - Kirkland Highway, in its entirety, as dedicated and recorded in Book 5 Pages 37-38, Book 5 Page 146, and Book 6 Pages 64-65 of Maps and Plats, **changed to Iron Springs Road**, as shown on Exhibit A.

Kirkland - Skull Valley Highway, in its entirety, as dedicated and recorded in Book 5 Page 110 of Maps and Plats, **changed to Iron Springs Road**, as shown on Exhibit A.

Walters Road, beginning at its intersection with Iron Springs Road, thence Westerly to its termination, **changed to Van Dickson Road**, as shown on Exhibit B.

Old Road North, beginning at its intersection with Copper Basin Road, thence north to its termination, **changed to Peavine Road**, as shown on Exhibit C.

Restaurant Road, in its entirety, **changed to Peavine Road**, as shown on Exhibit C.

Old Road North, a portion of, beginning at its intersection with Iron Springs Road, thence north to its termination, **changed to Old Skull Valley Road**, as shown on Exhibit D.

Old Road South, in its entirety, **changed to Old Skull Valley Road**, as shown on Exhibit D.

WHEREAS, streets not previously officially named have been named **Webb Ranch Road**, **Woosley Spring Road**, **De Spain Place**, **Patterson Road**, and **Grisby Road** as shown on Exhibit E.

WHEREAS, streets not previously officially named have been named **Over The Hill Road**, **Baldwin Lane**, **Kelton Lane**, **Hodge Meadow Lane**, **Happy Dog Drive**, **Bull Elk Ridge**, **Elderberry Lane**, **Sexton Road**, and **Gist Road** as shown on Exhibit F.

WHEREAS, streets not previously officially named have been named **Four Cross Ranch Road**, **D'Armond Dairy Road**, **Casa Negro Road**, **Windmill Road**, **Armistad Lane**, **Overton Road**,

Cedar Street, Shook Road, Briggs Road, Musgrove Road, and Earnhart Road as shown on Exhibit G.

The Official Street Name Map for the Skull Valley area is recorded in Book 50 Pages 6 of Maps and Plats.

All above recordations are on file in the office of the Yavapai County Recorder, Prescott, Arizona.

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that the names of the streets as described above and as shown on Exhibit A - Exhibit G, be changed.

These name changes shall become effective 60 days after the date approved by the Board of Supervisors.

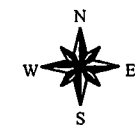


PEAVINE RD

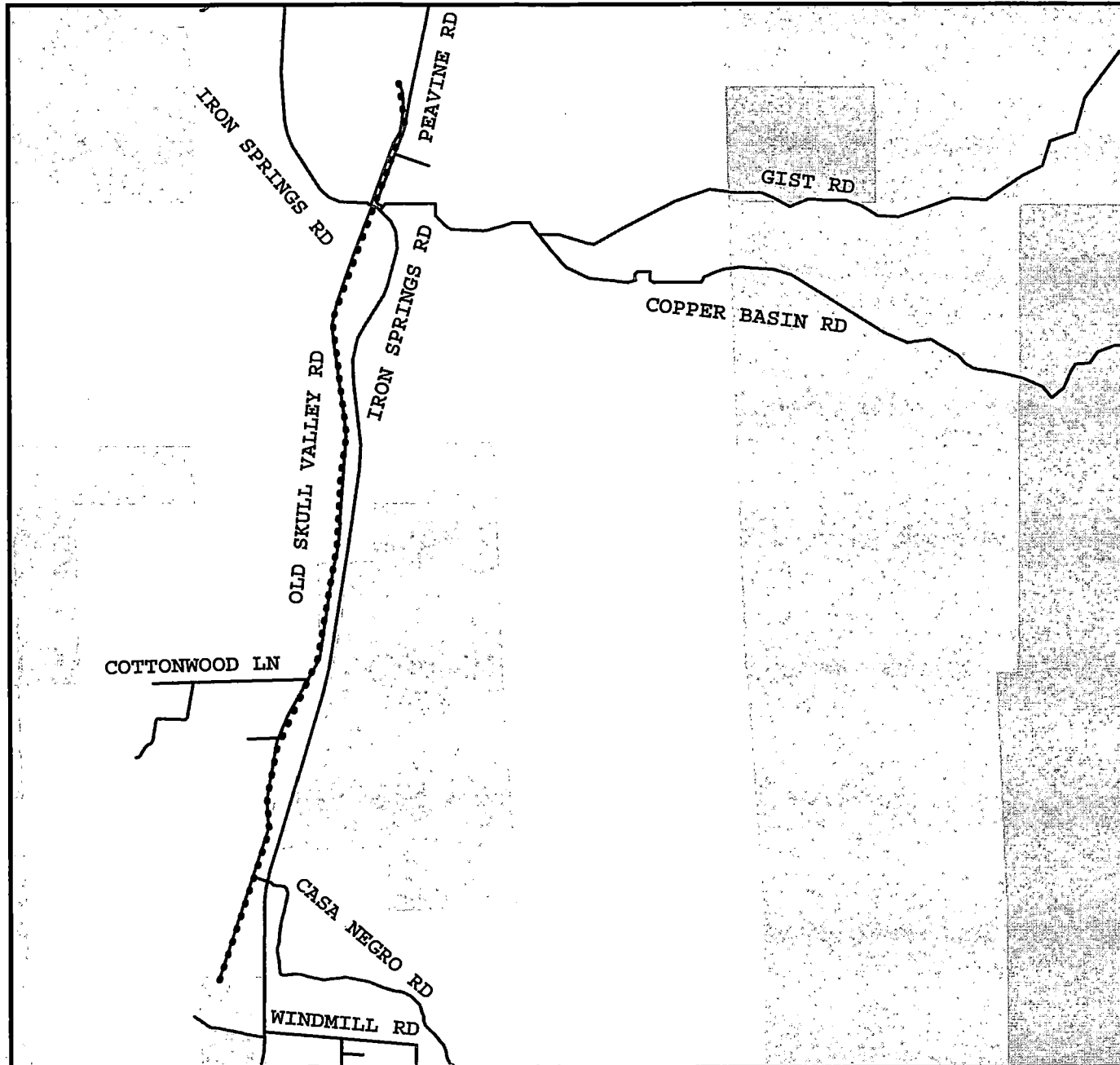

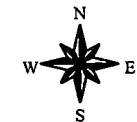


OLD SKULL VALLEY RD
