RESOLUTION NO. 1561

EAST HOLLY DRIVE AND TRANQUIL TRAIL (a portion of) TO GRAND VIEW ROAD

WHEREAS, the Addressing / 911 Coordinator identified a street with multiple street names, in the Prescott area;

WHEREAS, contiguous streets with the different names causes confusion during emergency response and potentially a delay during emergency response;

WHEREAS, the requested street name changes will improve public safety;

WHEREAS, the referenced portions of East Holly Drive and Tranquil Trail is confusing to the public and emergency agencies, because they are in direct alignment with Grand View Road;

East Holly Drive, in its entirety, as dedicated and recorded in Book 11 of Maps and Plats Page 14 and in Book 10 of Maps and Plats Page 98 and **Tranquil Trail**, a portion of, as dedicated and recorded in Book 10 of Maps and Plats Page 98, **changed to Grand View Road**, as shown on Exhibit A.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming East Holly Drive and a portion of Tranquil Trail to Grand View Road;

WHEREAS, a notice of hearing was printed in the Prescott Courier on November 28, 2004, posted along the referenced streets, mailed out to the Yavapai County Sheriff's Office, Central Yavapai Fire District, Public Works Department, and the adjacent property owners to the above referenced street;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on December 6, 2004;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that East Holly Drive and Tranquil Trail as described above and as illustrated on the attached Exhibit A, be changed to Grand View Road.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

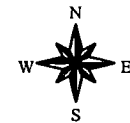
