**RESOLUTION ORDERING A SPECIAL ELECTION TO BE HELD IN
AND FOR MONTEZUMA RIMROCK FIRE DISTRICT OF YAVAPAI
COUNTY, ARIZONA, ON SEPTEMBER 13, 2005**

WHEREAS, on April 18, 2005, the Board of Directors of the Montezuma Rimrock Fire District of Yavapai County, Arizona (the "*District*") adopted a resolution ordering and calling a special election be held in and for the District for the purpose of adopting the 2003 International Fire Code, and it is now in order for this Board to order the special election pursuant to A.R.S. § 48-805(B)(5);

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY, ARIZONA, THAT, pursuant to A.R.S. §48-805(B)(5), a special election shall be held in and for the Montezuma Rimrock Fire District of Yavapai County, Arizona, on September 13, 2005, in accordance with the attached Order of Election which is incorporated by reference into this resolution.

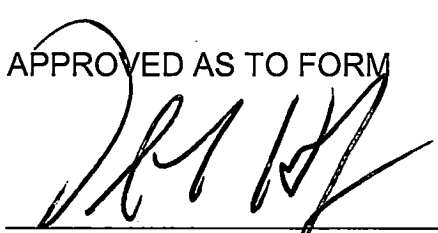

ORDER OF ELECTION

A special election is hereby ordered in and for the Montezuma Rimrock Fire District, of Yavapai County, Arizona.

1. The purpose of the election is to place on the ballot the question of whether the Fire District should adopt the International Fire Code, a nationally recognized fire code approved by the Arizona State Fire Marshal.
2. The election shall be held on September 13, 2005, between the hours of 6:00 a.m. and 7:00 p.m. (MST).
3. The location of the polling place for the election is:

Beaver Creek Precinct
Adult Center
4250 E. Zuni Way
Lake Montezuma, Arizona
4. The last day to register to vote in the election is August 15, 2005.
5. Early voting for the election will begin August 11, 2005.
6. Early ballots may be requested by contacting the Yavapai County Recorder's Office, Voter Registration Division, 1015 Fair Street, Prescott, Arizona, 928-771-3248.
7. Early ballots may be mailed to the Yavapai County Recorder's Office, 1015 Fair Street, Prescott, Arizona, 86305 or delivered to any polling place on the day of the election until voting closes at 7:00 p.m. (MST).

8. Early ballots may be voted in person at the following location:

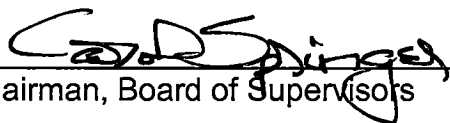
