

RESOLUTION NO. 1753

MT MINGUS AVENUE TO MT MINGUS ROAD MINGUS VIEW DRIVE TO MT MINGUS ROAD

WHEREAS, the Addressing / 911 Coordinator identified a street known as two different street names, in the Cottonwood area;

WHEREAS, different street names along the same road causes confusion during emergency response and potentially a delay during emergency response;

WHEREAS, Mt Mingus Avenue, in it's entirety, is confusing to the public and emergency agencies, because street signs indicate Mingus View Drive and a majority of the property owners are utilizing Mingus View Drive as their address;

WHEREAS, Mt Mingus Avenue and Mingus View Drive, in their entirety, are being requested by property owners to change to Mt Mingus Road eliminating any confusion to the public and emergency agencies.

WHEREAS, the requested street name change will improve public safety;

Mt Minugs Avenue, in it's entirety, as dedicated and recorded in Book 2 of Maps and Plats Page 29, **changed to Mt Mingus Road**, as shown on Exhibit A.

Mingus View Drive, in it's entirety, **changed to Mt Mingus Road**, as shown on Exhibit A.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming Mt Mingus Avenue and Mingus View Drive to Mt Mingus Road;

WHEREAS, a notice of hearing was printed in the Verde Independent on September 12, 2010, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Verde Valley Fire District, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on September 20, 2010;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Mt Mingus Avenue and Mingus View Drive as described above and as illustrated on the attached Exhibit A, be changed to Mt Mingus Road.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

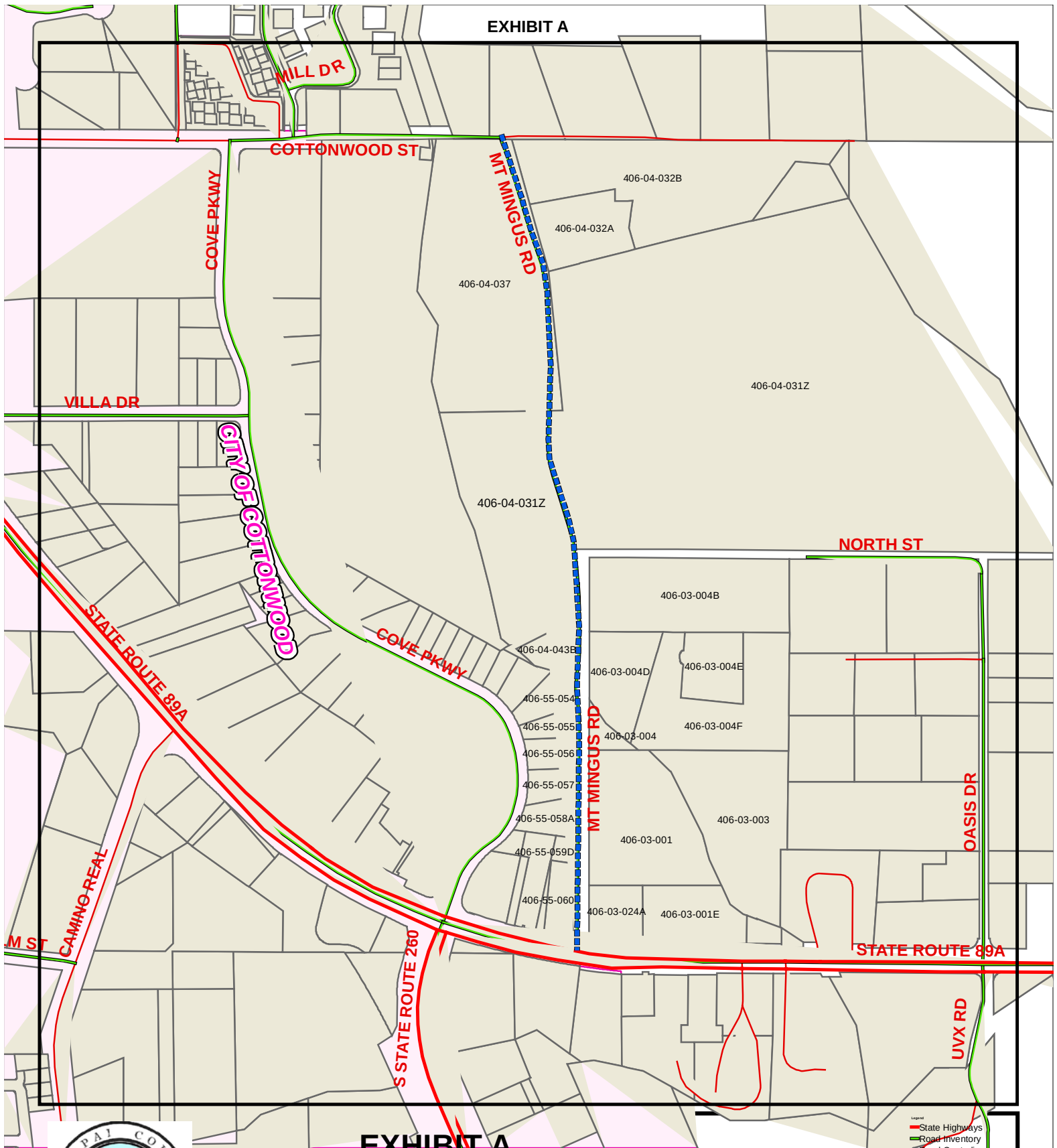
