RESOLUTION NO. 1857

RESOLUTION OF THE BOARD OF SUPERVISORS RENAMING TOLEMAC ROAD TO TOLEMAC WAY

WHEREAS, the Addressing / 911 Coordinator and the public have identified a street known as two different street names, in the Prescott area;

WHEREAS, different street names along the same road causes confusion during emergency response and potentially a delay during emergency response;

WHEREAS, the requested street name change will improve public safety;

WHEREAS, the road officially named Tolemac Road is confusing to the public and emergency agencies, because street signs indicate Tolemac Way at Iron Springs Road and a majority of the property owners are utilizing Tolemac Way as their address;

Tolemac Road, in its entirety, as dedicated and recorded in Book 32 of Maps and Plats Pages 21 & 22, **changed to Tolemac Way**, as shown on Exhibit A.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming Tolemac Road to Tolemac Way;

WHEREAS, a notice of hearing was printed in the Daily Courier on January 26, 2014, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Central Yavapai Fire District, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on February 3, 2014;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Tolemac Road, as described above and as illustrated on the attached Exhibit A, be changed to Tolemac Way.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

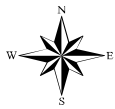
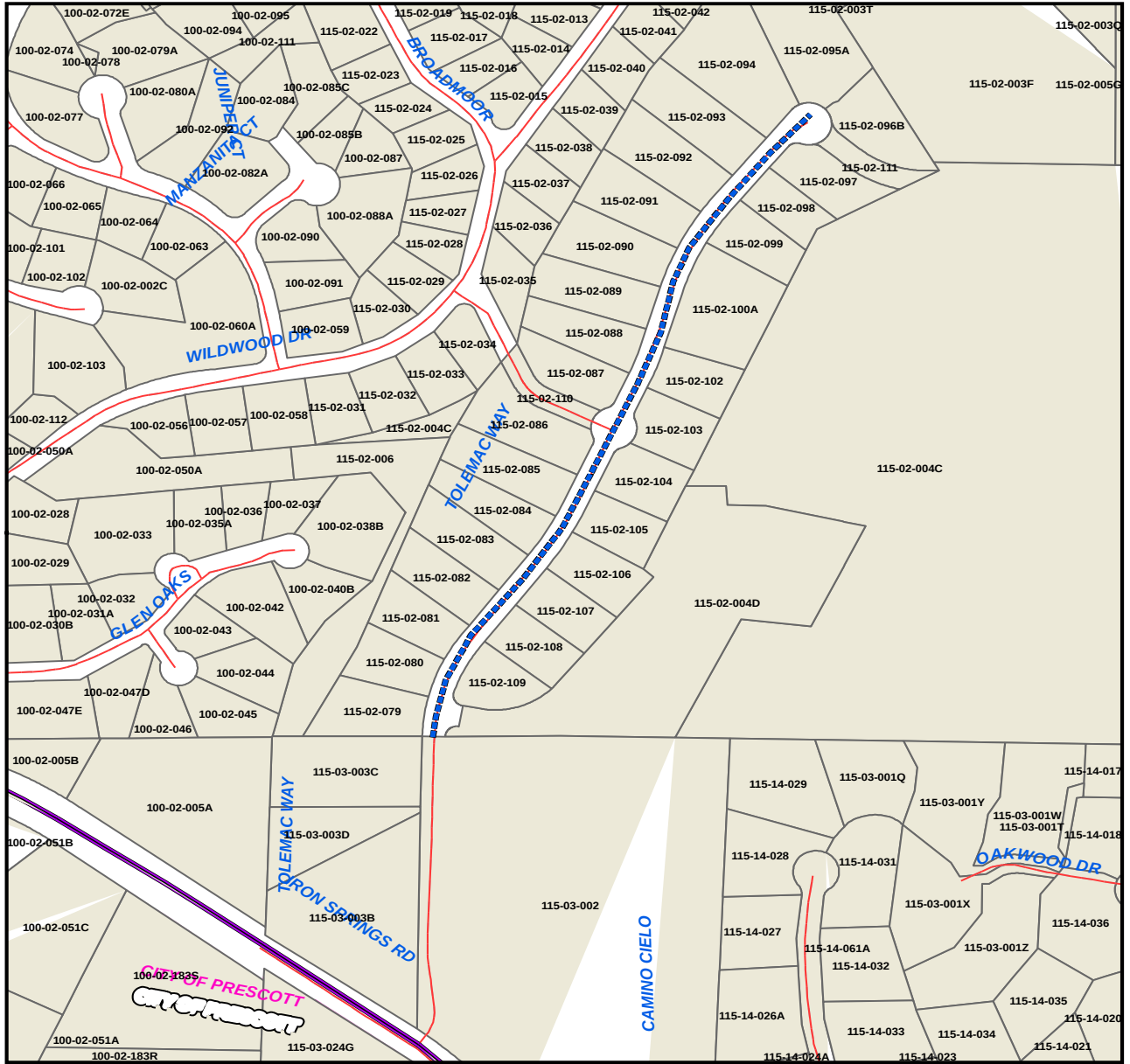

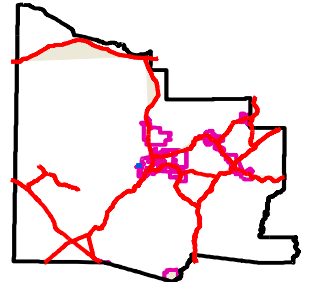
