RESOLUTION NO. 1870

RESOLUTION OF THE BOARD OF SUPERVISORS RENAMING RADCLIFF ROAD AND MALOOF ROAD TO LAWRENCE LANE

WHEREAS, the Addressing / 911 Coordinator has identified a street known as three different street names, in the Prescott Valley area;

WHEREAS, different street names along the same road causes confusion during emergency response and potentially a delay during emergency response;

WHEREAS, the requested street name change will improve public safety;

WHEREAS, the road named Radcliff Road, Maloof Road, and Lawrence Lane is confusing to the public and emergency agencies, due to the road being alternatingly named on different maps;

WHEREAS, street signs randomly indicate all three names and a majority of the property owners are utilizing Lawrence Lane as their address;

Radcliff Road, in its entirety, **changed to Lawrence Lane**, as shown on Exhibit A.

Maloof Road, in its entirety, **changed to Lawrence Lane**, as shown on Exhibit B.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming Radcliff Road and Maloof Road to Lawrence Lane;

WHEREAS, a notice of hearing was printed in the Daily Courier on May 25, 2014, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Central Yavapai Fire District, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on June 2, 2014;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Radcliff Road, as described above and as illustrated on the attached Exhibit A, be changed to Lawrence Lane.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Maloof Road, as described above and as illustrated on the attached Exhibit B, be changed to Lawrence Lane.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

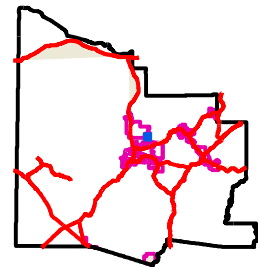

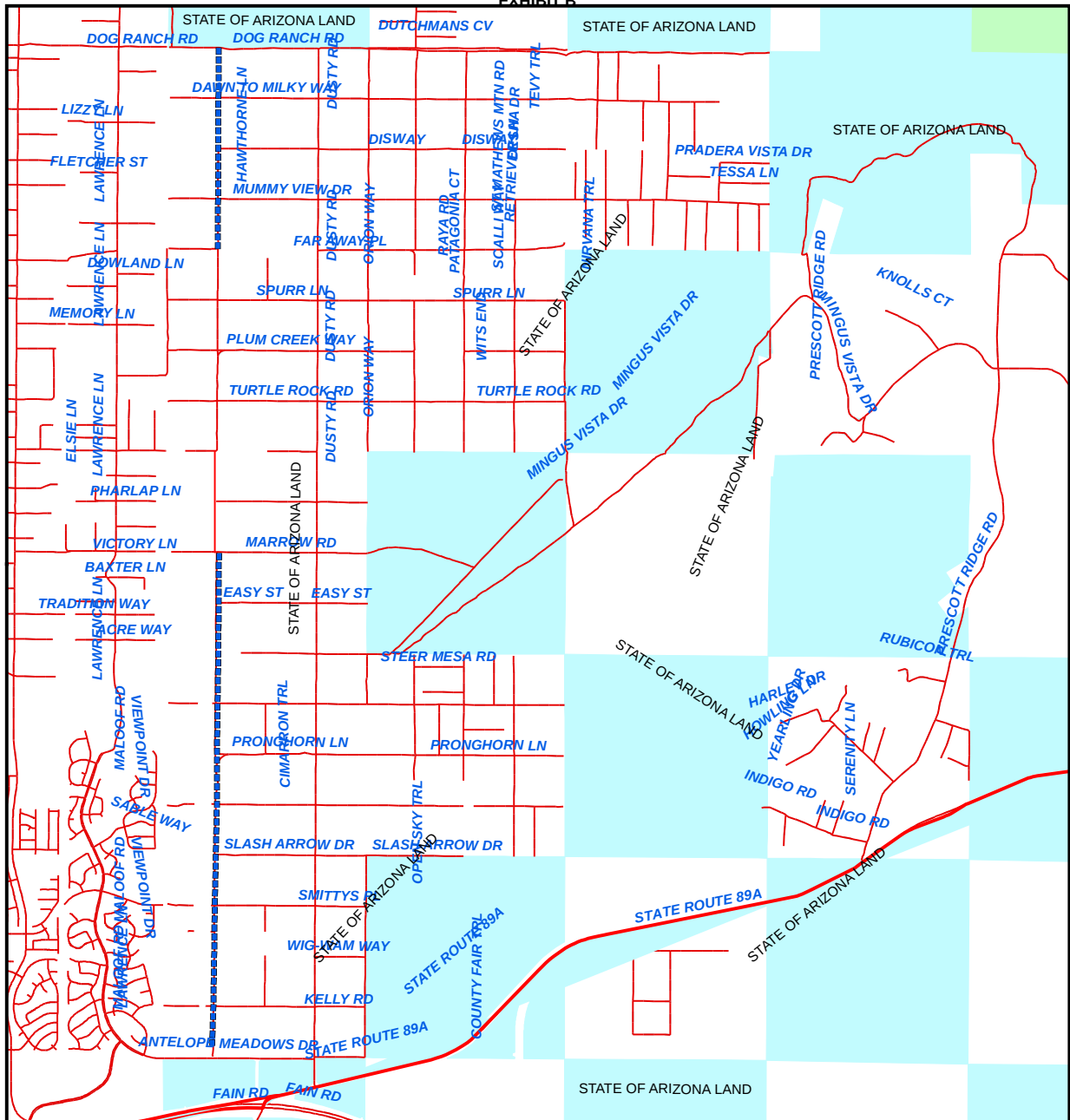

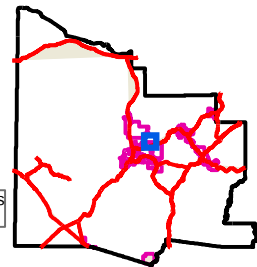
