### **RESOLUTION NO. 1885**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY  
AUTHORIZING THE CANCELING OF ELECTIONS FOR BLACK CANYON  
CITY, DIAMOND VALLEY, HOLIDAY HILLS, PONDEROSA PARK AND QUAIL  
RIDGE DOMESTIC WATER IMPROVEMENT DISTRICTS; HIGH VALLEY  
RANCH, TAPADERO, AND WEAVER MOUNTAIN DOMESTIC WASTEWATER  
IMPROVEMENT DISTRICTS; SHERIFF'S POSSE COMMUNITY ROAD  
IMPROVEMENT AND MAINTENANCE DISTRICT; IRON SPRINGS SANITARY  
DISTRICTS; CENTRAL YAVAPAI HOSPITAL DISTRICT AND APPOINTING  
THE PERSONS WHO FILED NOMINATING PETITIONS**

**WHEREAS**, A.R.S. §48-1012(E) with regard to domestic water and wastewater improvement districts; and A.R.S. §48-1082(E) and A.R.S. §48-1092(E) with regard to road improvement districts; and A.R.S. §48-2010(A) with regards to sanitary districts; and A.R.S. §48-1908(C) with regards to hospital districts; provide that if only one person or no person files a nominating petition for election to fill a position on the board of directors of the district, the Board of Supervisors may cancel the election for that office and appoint the person who filed the nominating petition to fill the position; and

**WHEREAS**, two positions on the board of directors for Black Canyon City Domestic Water Improvement District were open for election and only one person filed a nominating petition; three positions on the board of directors for Diamond Valley Water District were open for election and only one person filed a nominating petition; three positions on the board of directors for Holiday Hills Domestic Water Improvement District were open for election and only two persons filed nominating petitions; two positions on the board of directors for Ponderosa Park Domestic Water Improvement District were open for election and only two persons filed nominating petitions; two positions on the board of directors for Quail Ridge Domestic Water Improvement District were open for election and only two persons filed nominating petitions; and,

**WHEREAS**, two positions on the board of directors for High Valley Ranch Domestic Waste Water Improvement District were open for election and only one person filed a nominating petition; one position on the board of directors for Tapadero Domestic Waste Water Improvement District was open for election and only one person filed a nominating petition; and two positions on the board of directors for Weaver Mountain Domestic Waste Water Improvement District and only two persons filed nominating petitions; and,

**WHEREAS**, one position on the board of directors for Sheriff's Posse Community Road Improvement and Maintenance District was open for election and only one person filed a nominating petition; and

**WHEREAS**, two positions on the Board of Directors of the Iron Springs Sanitary District were open for election and only two persons filed nominating positions; and,

**WHEREAS**, one position on the Board of Directors for the Central Yavapai Hospital District was open for election and no one filed nominating petitions; and,

**WHEREAS**, each district has requested that the Board of Supervisors cancel the election and appoint the persons who filed nominating petitions.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:** that the November 4, 2014, elections for boards of directors in Black Canyon City, Diamond Valley, Holiday Hills, Ponderosa Park and Quail Ridge Domestic Water Improvement Districts; High Valley Ranch, Tapadero, and Weaver Mountain Domestic Wastewater Improvement Districts; and Sheriff's Posse Community Road Improvement and Maintenance District; Iron Springs Sanitary District and Central Yavapai Hospital District are cancelled and the following persons who filed nominating petitions are appointed:

**Diamond Valley Water District** – David Mason

**Holiday Hills Domestic Water Improvement District** – Perry D. Hatcher and Rodney W. Mathis

**Ponderosa Park Domestic Water Improvement District** – David A. Jossis and Mary Meyers

**Quail Ridge Domestic Water Improvement District** – Nels E. Esquibel and Milton W. Vought

**High Valley Ranch Domestic Waste Water Improvement District** – Garey L. Seigerman

**Tapadero Domestic Waste Water Improvement District** – Larry C. Walz

**Weaver Mountain Domestic Waste Water Improvement District** – Michael A. Blanchard and John Burke

**Sheriff's Posse Community Road Improvement and Maintenance District** – Joe Veranth

**Iron Springs Sanitary District**- Valard P. Ripley and Frank L. Waples
