RESOLUTION NO. 1938

RESOLUTION OF THE BOARD OF SUPERVISORS RENAMING TEPEYAC RD TO COLD SPRINGS RD

WHEREAS, the United Christian Youth Camp has requested a street name change to reflect the camp name, in the Prescott area;

WHEREAS, the camp was recently purchased and the camp name was changed to “The Springs”, where geographically the Cold Springs is located on the property;

WHEREAS, currently Tepeyac Rd is in alignment with the street name Cold Springs Rd, beyond the camp;

WHEREAS, multiple names for a single road cause confusion during emergency response and potentially a delay during emergency response;

WHEREAS, the requested street name change will improve public safety;

Tepeyac Rd, in its entirety, **changed to Cold Springs Rd**, as shown on Exhibit A.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming Tepeyac Rd to Cold Springs Rd;

WHEREAS, a notice of hearing was printed in the Daily Courier on March 27, 2016, posted along the referenced street, mailed out to the Yavapai County Sheriff’s Office, Central Yavapai Fire District, Prescott Fire Department, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on April 6, 2016;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that Tepeyac Rd, as described above and as illustrated on the attached Exhibit A, be changed to Cold Springs Rd.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

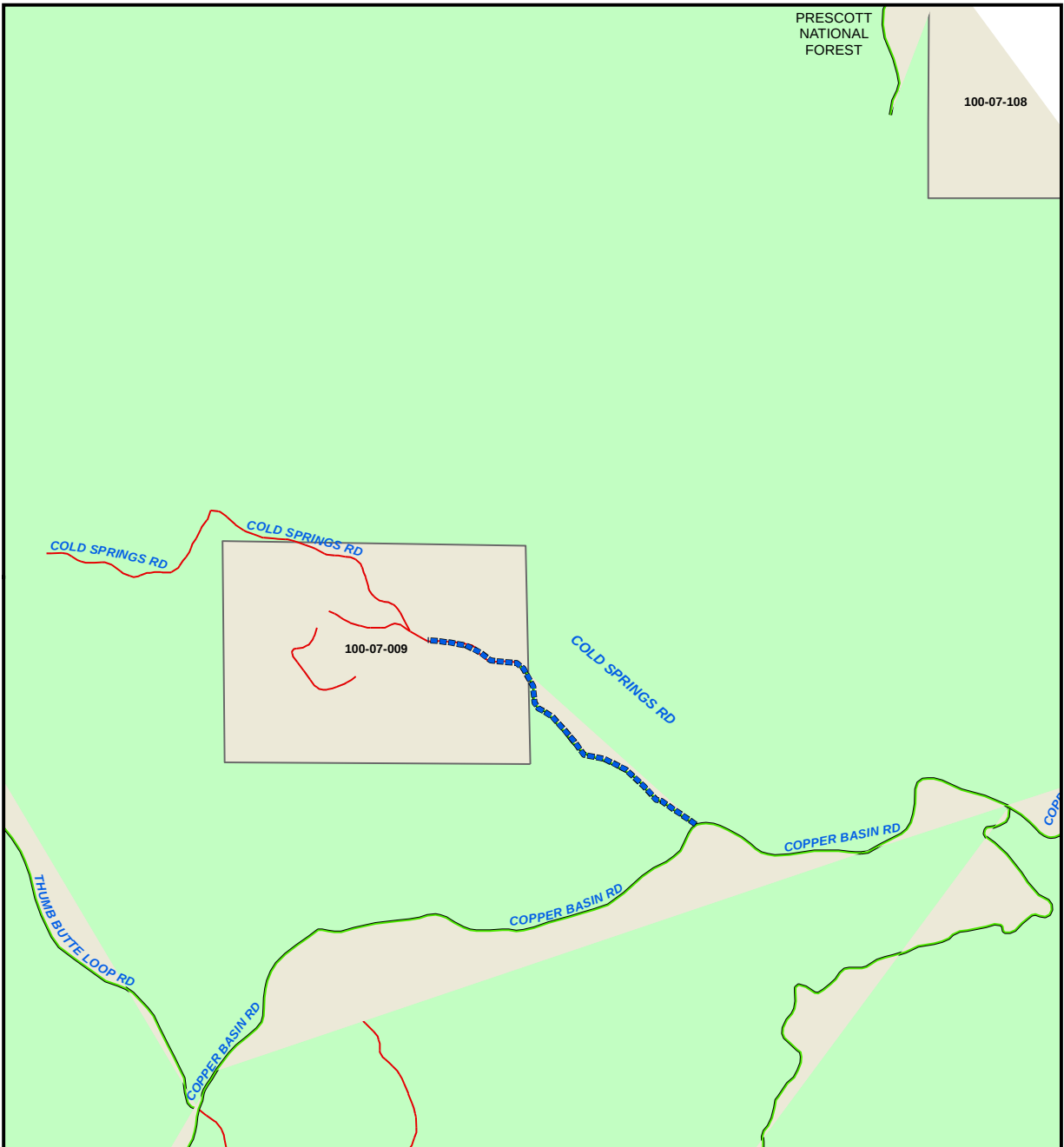

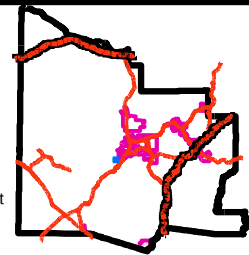
