RESOLUTION NO. 1940

RESOLUTION OF THE BOARD OF SUPERVISORS RENAMING A PORTION OF VERDE VALLEY SCHOOL RD TO CASTLE VISTA CT

WHEREAS, Eric Fraleigh, submitted a petition to rename the cul-de-sac adjacent to three (3) parcels, in the Village of Oak Creek area;

WHEREAS, the petition included the filing fee, base fee of \$300 plus \$20 each for the adjacent three (3) parcels, necessary to accept to the petition;

WHEREAS, sixty-seven percent of the property owners adjacent to the cul-de-sac signed the petition to rename the cul-de-sac to have its own unique street name;

WHEREAS, the same name for a multiple roads cause confusion during emergency response and potentially a delay during emergency response;

WHEREAS, the requested street name change will improve public safety;

Verde Valley School Rd, a portion of, **changed to Castle Vista Ct**, as shown on Exhibit A.

WHEREAS, a public hearing was set for the Yavapai County Board of Supervisors to consider renaming a portion of Verde Valley School Rd to Castle Vista Ct;

WHEREAS, a notice of hearing was printed in the Verde Independent on April 10, 2016, posted along the referenced street, mailed out to the Yavapai County Sheriff's Office, Sedona Fire District, Public Works Department, and the adjacent property owners to the above referenced streets;

WHEREAS, the Yavapai County Board of Supervisors held a public hearing on April 20, 2016;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of Yavapai County declares that a portion of Verde Valley School Rd, as described above and as illustrated on the attached Exhibit A, be changed to Castle Vista Ct.

This street name change shall become effective 60-days after the date approved by the Board of Supervisors.

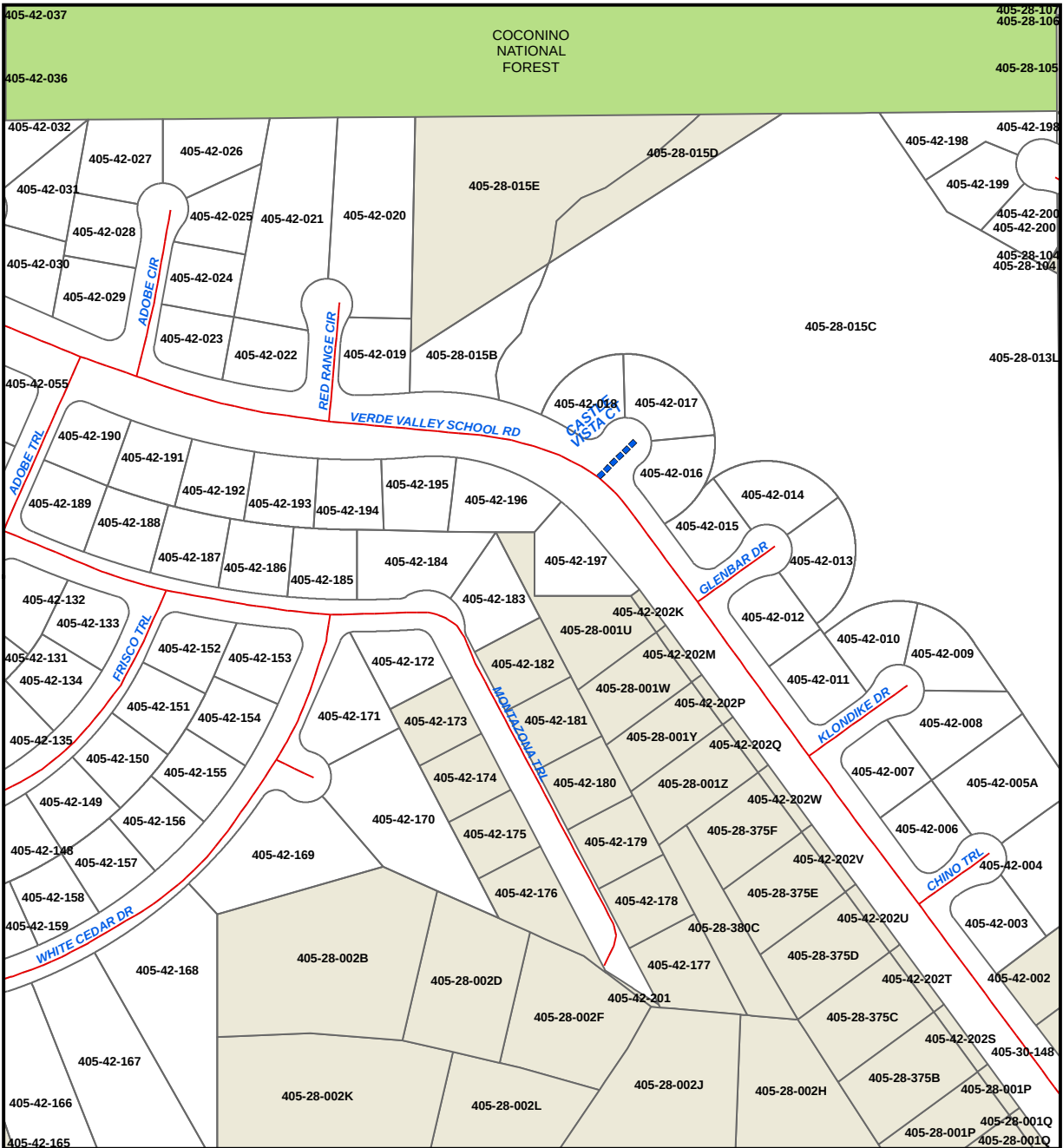

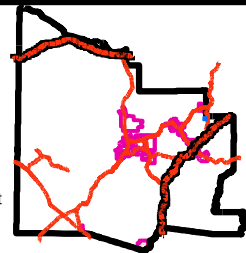
