



## YAVAPAI COUNTY BOARD OF SUPERVISORS

### RESOLUTION NO. 1970

#### **A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY AUTHORIZING THE CANCELING OF ELECTIONS FOR BIG PARK AND BRYCE CANYON DRIVE DOMESTIC WASTEWATER IMPROVEMENT DISTRICTS; AND APPOINTING THE PERSONS WHO FILED NOMINATION PETITIONS OR NOMINATION PAPERS**

**WHEREAS**, A.R.S. §48-1012(E), with regard to domestic wastewater improvement districts, provides that if only one person or no person files a nominating petition for election to fill a position on the board of directors of the district, the Board of Supervisors may, by resolution, cancel the election for that office and appoint the person who filed the nominating petition to fill the position; and

**WHEREAS**, A.R.S. §16-410(A), with regard to an election that is to be held pursuant to title 48, provides that if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the Board of Supervisors may cancel the election for that office no earlier than seventy-five days before the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated; and

**WHEREAS**, three positions on the board of directors for Big Park Domestic Wastewater Improvement District were open for election on November 7, 2017, and three candidates filed nominating petitions; and two positions on the board of directors for Bryce Canyon Drive Wastewater Improvement District were open for election on November 7, 2017, and two candidates filed nomination papers for write-in candidates; and,

**WHEREAS**, each district has requested that the Board of Supervisors cancel the election and appoint the persons who filed nominating petitions.

**NOW, THEREFORE, BE IT RESOLVED** that the November 7, 2017, elections for boards of directors in Big Park and Bryce Canyon Drive Domestic Wastewater Improvement Districts are cancelled and the following persons who filed nominating petitions are appointed:

**Big Park Wastewater Improvement District** –Ruth Kane, Gary Livermont, and David Sheets

**Bryce Canyon Drive Wastewater Improvement District** – Charlie Reyes and Lisa Reyes
