



YAVAPAI COUNTY BOARD OF SUPERVISORS

RESOLUTION NO. 1978

ESTABLISHING A PORTION OF GRANT STREET, PINE CONE WAY, OLD MUD SPRINGS ROAD, CEDAR COVE AND HILLSIDE COVE AS COUNTY HIGHWAYS

WHEREAS, the above matter came before the Yavapai County Board of Supervisors at its meeting on February 7, 2018, pursuant to legal notice thereof, at the request of the County Engineer and the petition filed with the Board of Supervisors, and the Board determining that the establishment of the following roads as County highways is a public necessity, having fully considered the feasibility, advantages, and necessity of its establishment:

GRANT STREET, Indian Creek Subdivision, as recorded in Book 6 of Maps and Plats, Page 58, beginning at its intersection with Deer Trail, thence northeasterly approximately 385 feet as shown on Exhibit "A";

PINE CONE WAY, Ponderosa Park No. 4, as recorded I Book 12 of Maps and Plats, Page 12, beginning at its intersection with Deer Trail, thence southwesterly approximately 275 feet as shown on Exhibit "A";

OLD MUD SPRINGS ROAD, Palo Verde Estates Subdivision, as recorded in Book 14 of Maps and Plats, Page 42, beginning at the northern boundary of the subdivision and terminating at the southern subdivision boundary as shown on Exhibit "B";

CEDAR COVE, Highland Pines Plat F Subdivision, as recorded in Book 12 of Maps and Plats, Page 82, beginning at its intersection with Papago Road, thence southerly approximately 300 feet as shown on Exhibit "C"; and

HILLSIDE COVE, Highland Pines Plat H Subdivision, as recorded in Book 16 of Maps and Plats, Page 24, beginning at its intersection with Happy Valley Road, thence easterly approximately 315 feet as shown on Exhibit "C".

NOW, THEREFORE, BE IT RESOLVED: (1) that the above described road be designated and established as a County Highway; and (2) that this resolution shall take effect when it is recorded in the office of the Yavapai County Recorder.

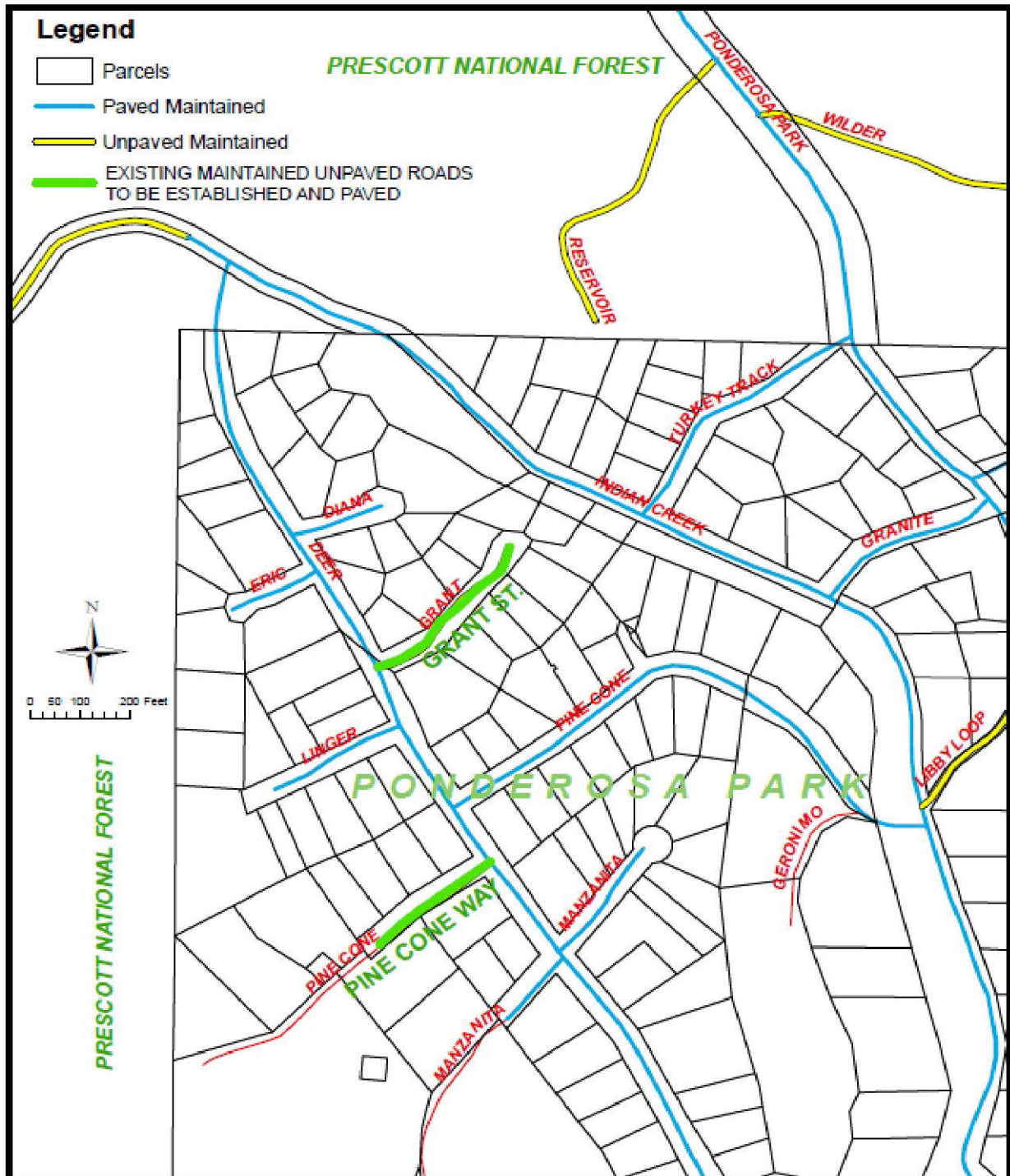

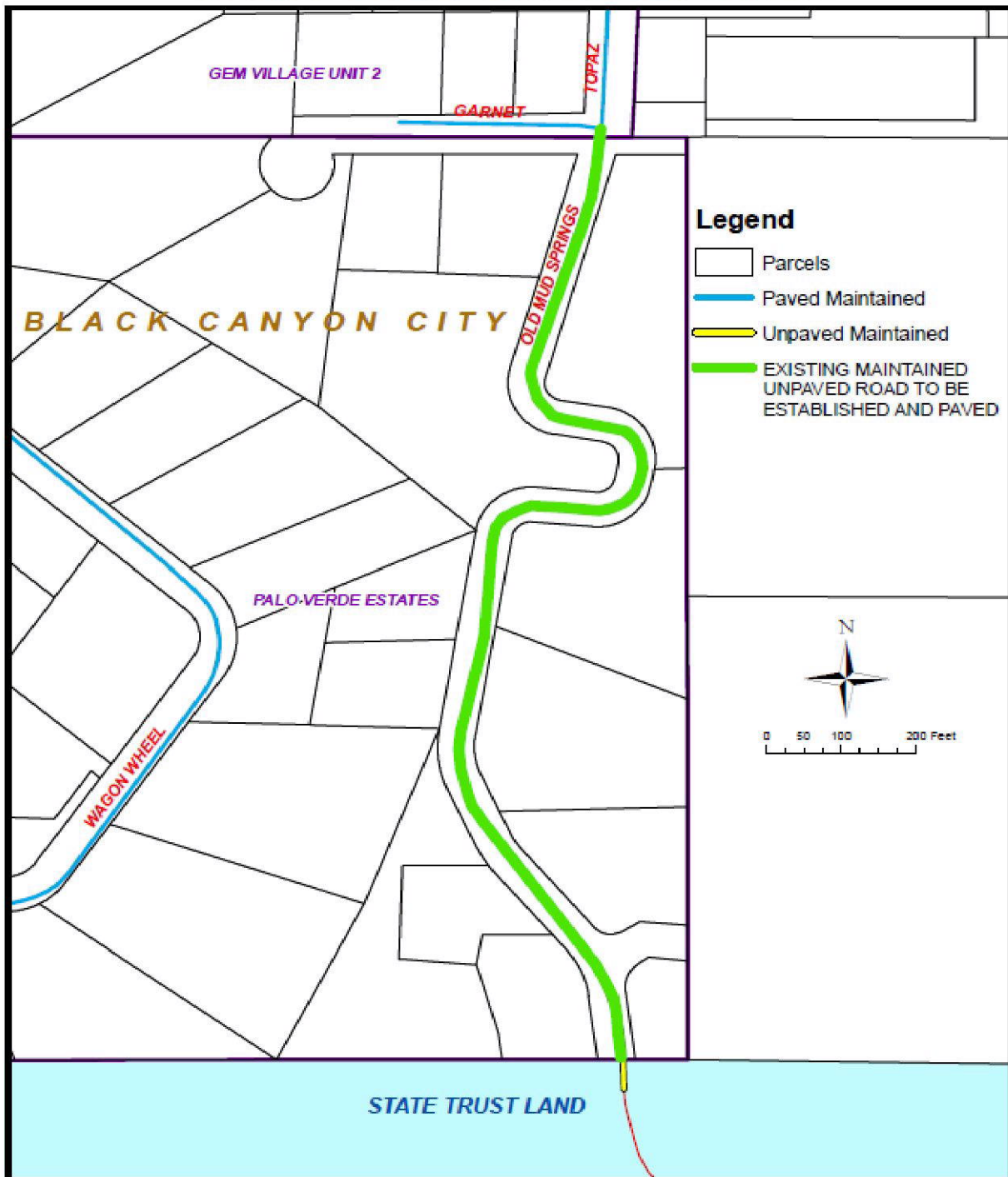
GRANT STREET AND PINE CONE WAY ESTABLISHMENT
