RESOLUTION NO. 1985

A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY DESIGNATING VOTE CENTERS FOR THE AUGUST 28, 2018 PRIMARY ELECTION AND NOVEMBER 6, 2018 GENERAL ELECTION

WHEREAS, A.R.S. §16-411(B) requires the Board of Supervisors to designate polling places in Yavapai County not less than 20 days before a Primary or General Election; and

WHEREAS, A.R.S. §16-411(B)(4) allows the Board of Supervisors to authorize, by resolution, the use of Vote Centers in place of specifically designated polling places; and

WHEREAS, the number of active voters who have chosen to be on the Permanent Early Voting List exceeds 75 percent.
