### **RESOLUTION NO. 2054**

#### **A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY, ARIZONA, DECLARING THE LAPSING OF WALNUT GROVE ELEMENTARY SCHOOL DISTRICT NO. 7 EFFECTIVE JULY 1, 2021, PURSUANT TO A.R.S. § 15-469**

**WHEREAS**, A.R.S. §15-469 establishes a process whereby the board of supervisors may declare a common school district lapsed and attach the territory to one or more of the adjoining school districts, dispose of the property of the lapsed common school district and apply the proceeds to the credit of the lapsed common school district if in a common school district there has been a student count of less than eight pupils between the ages of six and twenty-one years for one school year; and,

**WHEREAS**, Walnut Grove Elementary School District No. 7 has had a student count of less than eight pupils between the ages of six and twenty-one years for one school year; and,

**WHEREAS**, Walnut Grove Elementary School District No. 7 meets the conditions of A.R.S. § 15-469; and,

**WHEREAS**, Walnut Grove Elementary School District No. 7 does not have any secondary debt and does not own or have to dispose of any property; and,

**WHEREAS**, lapsing Walnut Grove Elementary School District No. 7 is reasonable for its residents and is in the best educational interest of its students; and,

**WHEREAS**, on February 3, 2021, the Governing Board of Walnut Grove Elementary School District No. 7, unanimously passed a Resolution Regarding Lapsing Walnut Grove Elementary School District No. 7 (a common school district) Effective July 1, 2021, Pursuant to A.R.S. § 15-469, a copy of which is attached hereto as EXHIBIT 1; and,

**WHEREAS**, on February 10, 2021, the Governing Board of Western Maricopa Education Center #402 (West-MEC) Career and Technical Education District (CTED) unanimously passed a Resolution Regarding Lapsing Walnut Grove Elementary School District No. 7 (a common school district) Effective July 1, 2021, Pursuant to A.R.S. § 15-469, a copy of which is attached hereto as EXHIBIT 2; and,

**WHEREAS**, on March 3, 2021, the Governing Board of Kirkland Elementary School District No. 23 unanimously passed a Resolution Regarding Lapsing Walnut Grove Elementary School District No. 7 (a common school district) Effective July 1, 2021, Pursuant to A.R.S. § 15-469, a copy of which is attached hereto as EXHIBIT 3; and,

**WHEREAS**, on March 9, 2021, the Governing Board of Wickenburg Unified School District No. 9 in Maricopa County (also known as Wickenburg Unified School District No. 60 in Yavapai County) unanimously passed a Resolution Regarding Lapsing Walnut Grove Elementary School District No. 7 (a common school district) Effective July 1, 2021, Pursuant to A.R.S. § 15-469, a copy of which is attached hereto as EXHIBIT 4.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**

1. That pursuant to A.R.S. §15-469, Walnut Grove Elementary School District No. 7 shall be declared lapsed effective July 1, 2021 (meaning Walnut Grove Elementary School District No. 7 shall cease to exist as of 11:59:59 p.m. on June 30, 2021).
2. That the Governing Board of Walnut Grove Elementary School District No. 7 shall be dissolved effective July 1, 2021, with the terms of all Governing Board members to be deemed to have expired as of that date.
3. That the Yavapai County School Superintendent shall determine all unbonded indebtedness of Walnut Grove Elementary School District No. 7 and draw his warrant, on proper vouchers, on the Yavapai County Treasurer in payment of the unbonded indebtedness with any balance remaining after such a payment to be transferred to the county school fund, in accordance with A.R.S. § 15-469.
4. That the current boundary of Walnut Grove Elementary School District No. 7 shall, as of July 1, 2021, be attached to the territory of adjoining school districts Kirkland Elementary School District No. 23 in Yavapai County, Wickenburg Unified School District No. 9 in Maricopa County (also known as Wickenburg Unified School District No. 60 in Yavapai County), and Western Maricopa Education Center #402 (West-MEC) Career and Technical Education District (CTED).
5. That the portion of Walnut Grove Elementary School District No. 7 to be attached to the territory of Kirkland Elementary School District No. 23 in Yavapai County is legally described in EXHIBIT “A” attached hereto.
6. That the portion of Walnut Grove Elementary School District No. 7 to be attached to the territory of Wickenburg Unified School District No. 9 in Maricopa County (also known as Wickenburg Unified School District No. 60 in Yavapai County) is legally described in EXHIBIT “B” attached hereto.
7. That the portion of Walnut Grove Elementary School District No. 7 to be attached to the territory of West-MEC CTED is legally described in EXHIBIT “C” attached hereto.
8. That the current and proposed boundaries of Walnut Grove Elementary School District No. 7, Kirkland Elementary School District No. 23, Wickenburg Unified School District No. 9 in Maricopa County (also known as Wickenburg Unified School District No. 60 in Yavapai County), and West-MEC CTED are further depicted in the maps in EXHIBIT “D” attached hereto.
