RESOLUTION NO. 2083

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY
DESIGNATING VOTE CENTERS FOR THE AUGUST 2, 2022 PRIMARY
ELECTION AND NOVEMBER 8, 2022 GENERAL ELECTION**

WHEREAS, A.R.S. §16-411(B) requires the Board of Supervisors to designate polling places in Yavapai County not less than 20 days before a Primary or General Election; and

WHEREAS, A.R.S. §16-411(B)(4) allows the Board of Supervisors to authorize, by resolution, the use of Vote Centers in place of specifically designated polling places; and

WHEREAS, the number of active voters who have chosen to be on the Active Early Voting List exceeds 79 percent, indicating that the number of voters who appear at a Vote Center on election day is likely to be substantially reduced.

NOW, THEREFORE, BE IT RESOLVED that following locations are designated as Vote Centers in Yavapai County for the August 2, 2022 Primary Election and November 8, 2022 General Election:
