RESOLUTION NO. 2093

A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY AUTHORIZING THE CANCELING OF ELECTIONS FOR AMERICAN RANCH, BLACK CANYON CITY, CONGRESS, DIAMOND VALLEY, HIGHLAND PINES, HOLIDAY HILLS, MYSTIC HEIGHTS, OAK CREEK, PONDEROSA PARK, QUAIL RIDGE, RETREAT AT OAK CREEK, TIPEJI, VENTURA RANCH, AND YAVAPAI RANCH DOMESTIC WATER IMPROVEMENT DISTRICTS; CALVARY CHAPEL, HIGH VALLEY RANCH, KINGS RANCH UNIT 2, MYSTIC HEIGHTS, AND WEAVER MOUNTAIN DOMESTIC WASTE WATER IMPROVEMENT DISTRICTS; SHERIFF'S POSSE COMMUNITY ROAD IMPROVEMENT AND MAINTENANCE DISTRICT; AND ASH FORK, CREEKSIDE, AND INSCRIPTION CANYON RANCH SANITARY DISTRICTS; AND APPOINTING THE PERSONS WHO FILED NOMINATING PAPERS

WHEREAS, A.R.S. § 16-410(A) provides that for an election held pursuant to Title 48, if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the county board of supervisors may cancel the election no earlier than one hundred five days before the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated by the qualified electors.

WHEREAS, A.R.S. § 16-410(B) provides that a person who is appointed pursuant to A.R.S. § 16-410 (A) is fully vested with the powers and duties of the office as if elected to that office.

Water Improvement District were open for election and two persons filed nominating papers; two positions on the board of directors for Ponderosa Park Domestic Water Improvement District were open for election and one person filed nominating papers; one position on the board of directors for Quail Ridge Domestic Water Improvement District was open for election and one person filed nominating papers; two positions on the board of directors for Retreat at Oak Creek Domestic Water Improvement District were open for election and no one filed nominating papers; one position on the board of directors for Stringfield Ranch Domestic Water Improvement District was open for election and no one filed nominating papers; two positions on the board of directors for TiPeJi Domestic Water Improvement District were open for election and no one filed nominating papers; two positions on the board of directors for Ventura Ranch Domestic Water Improvement District were open for election and no one filed nominating papers; two positions on the board of directors for Yavapai Ranch Domestic Water Improvement District were open for election and no one filed nominating papers; two positions on the board of directors for Yavapai Ranch Domestic Water Improvement District were open for election and no one filed nominating papers; and,

WHEREAS, one position on the board of directors for Calvary Chapel Domestic Waste Water Improvement District was open for election and no one filed nominating papers; two positions on the board of directors for High Valley Ranch Domestic Waste Water Improvement District were open for election and no one filed nominating papers; two positions on the board of directors for Kings Ranch Unit 2 Domestic Waste Water Improvement District were open for election and no one filed nominating papers; two positions on the board of directors for Mystic Heights Domestic Waste Water Improvement District were open for election and no one filed nominating papers; and three positions on the board of directors for Weaver Mountain Domestic Waste Water Improvement District were open for election and no one filed nominating papers; and,

WHEREAS, one position on the board of directors for Sheriff's Posse Community Road Improvement and Maintenance District was open for election and one person filed nominating papers; and

WHEREAS, one position on the board of directors for Ash Fork Sanitary District was open for election and no one filed nominating papers; two positions on the board of directors for Creekside Sanitary District were open for election and no one filed nominating papers; and one position on the board of directors for Inscription Canyon Ranch Sanitary District was open for election and one person filed nominating papers; and

WHEREAS, each district has requested that the Board of Supervisors cancel the election and appoint the persons who filed nominating papers.

NOW, THEREFORE, BE IT RESOLVED that the November 8, 2022 elections for boards of directors in American Ranch, Black Canyon City, Congress, Diamond Valley, Highland Pines, Holiday Hills, Mystic Heights, Oak Creek, Ponderosa Park, Quail Ridge, Retreat at Oak Creek, Stringfield Ranch, TiPeJi, Ventura Ranch, and Yavapai Ranch Domestic Water Improvement Districts; Calvary Chapel, High Valley Ranch, Kings Ranch Unit 2, Mystic Heights, and Weaver Mountain Domestic Waste Water Improvement Districts; Sheriff's Posse Community Road Improvement And Maintenance District; and Ash Fork, Creekside, and Inscription Canyon Ranch Sanitary Districts; are
