## **RESOLUTION NO. 2105**

AMENDING RESOLUTION NO. 2092 OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY AUTHORIZING THE CANCELING OF ELECTIONS FOR ASH FORK, CENTRAL YAVAPAI, CHINO VALLEY, CONGRESS, CROWN KING, DAISY MOUNTAIN, GROOM CREEK, MAYER, SEDONA, SELIGMAN, VERDE VALLEY, WICKENBURG RURAL, WILLIAMSON VALLEY, AND YARNELL FIRE DISTRICTS; AND APPOINTING THE PERSONS WHO FILED NOMINATING PAPERS

WHEREAS, A.R.S. § 16-410(A) provides that for an election held pursuant to Title 48, if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the county board of supervisors may cancel the election no earlier than one hundred five days before the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated by the qualified electors;

WHEREAS, A.R.S. § 16-410(B) provides that a person who is appointed pursuant to A.R.S. § 16-410 (A) is fully vested with the powers and duties of the office as if elected to that office;

**WHEREAS,** on August 17, 2022, the Yavapai County Board of Supervisors passed Resolution No. 2092 cancelling various fire district elections;

**WHEREAS**, due to scrivener's errors on the original resolution corrections are required as contained herein;

**NOW, THEREFORE, BE IT RESOLVED** that the following persons are appointed to the vacancies created by the cancellation of the Ash Fork Volunteer Fire District, Central Yavapai Fire District and Crown King Fire District elections as set out in the third paragraph of Resolution No. 2092, in addition to those appointments already made in Resolution No. 2092:

Ash Fork Volunteer Fire District - Roy Hume

Central Yavapai Fire District - Andrew Reinhardt

Crown King Fire District - David Drye

**IT IS FURTHER RESOLVED** that Resolution No 2092 shall be amended, *nunc pro tunc*, to reflect the corrections stated herein.
