RESOLUTION NO. 2138

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF YAVAPAI COUNTY
AUTHORIZING THE CANCELING OF ELECTIONS FOR ASH FORK VOLUNTEER,
CENTRAL YAVAPAI, CHINO VALLEY, CONGRESS, COPPER CANYON FIRE &
MEDICAL, GROOM CREEK, MAYER VOLUNTEER, PEEPLES VALLEY, SEDONA,
SELIGMAN VOLUNTEER, VERDE VALLEY, WILLIAMSON VALLEY, AND
YARNELL FIRE DISTRICTS; AND APPOINTING THE PERSONS
WHO FILED NOMINATING PAPERS**

WHEREAS, A.R.S. § 16-410(A) provides that for an election held pursuant to Title 48, if the total of the number of persons who file a nomination petition for a candidate and the number of persons who file a nomination paper for a write-in candidate is less than or equal to the number of positions to be filled at the election for which the nomination petition or nomination paper is filed, the county board of supervisors may cancel the election no earlier than one hundred five days before the election and appoint the person or persons who filed the nomination petition or nomination paper to fill the position for the term of office for which the candidate was nominated by the qualified electors; and

WHEREAS, A.R.S. § 16-410(B) provides that a person who is appointed pursuant to A.R.S. § 16-410(A) is fully vested with the powers and duties of the office as if elected to that office; and

WHEREAS, one position on the Board of Directors for Ash Fork Volunteer Fire District was open for election and no one filed nominating papers; three positions on the Board of Directors for Central Yavapai Fire District were open for election and three persons filed nominating papers; three positions on the Board of Directors for Chino Valley Fire District were open for election and two persons filed nominating papers; one position on the Board of Directors for Congress Fire District was open for election and one person filed nominating papers; two positions on the Board of Directors for Copper Canyon Fire & Medical District were open for election and one person filed nominating papers; two positions on the Board of Directors for Groom Creek Fire District were open for election and no one filed nominating papers; two positions on the Board of Directors for Mayer Volunteer Fire District were open for election and two persons filed nominating papers; two positions on the Board of Directors for Peoples Valley Fire District were open for election and no one filed nominating papers; two positions on the Board of Directors for Sedona Fire District were open for election and two persons filed nominating papers; one position on the Board of Directors for Seligman Volunteer Fire District was open for election and no one filed nominating papers; and

WHEREAS, three positions on the board of Directors for Verde Valley Fire District were open for election and two persons filed nominating papers; three positions on the Board of Directors for Williamson Valley Fire District were open for election and two persons filed nominating papers; and three positions on the Board of Directors for Yarnell Fire District were


open for election and three persons filed nominating papers; and

WHEREAS, each district has requested that the Board of Supervisors cancel the election and appoint the persons who filed nominating papers; and

NOW, THEREFORE, BE IT RESOLVED that the November 5, 2024, elections for Boards of Directors in Ash Fork Volunteer, Central Yavapai, Chino Valley, Congress, Copper Canyon Fire & Medical, Groom Creek, Mayer Volunteer, Peoples Valley, Sedona, Seligman Volunteer, Verde Valley, Williamson Valley, and Yarnell Fire Districts; are canceled and the following persons who filed nominating papers are appointed:


